**MOTION ON CONSENT TO AMEND APPLICATION AND,  
IF ACCEPTED, TO WITHDRAW THE OPPOSITION ON CONSENT**

Pursuant to Rule 2.133 of the Trademark Rules of Practice, Applicant respectfully requests that the above-captioned application be amended as follows:

Sports Training and Education Programs, namely, programs for athletes to improve athletic performance; Educational services, namely, four year high school curriculum courses relating to sports and athletics, instruction and training in swimming, soccer, track and field, lacrosse, volleyball; ~~€~~Training programs to improve physical athletic performance; ~~p~~Providing seminars, workshops, and classes in the field of sports, and the publication and distribution of course materials in connection therewith; ~~s~~Sports refereeing and officiating, providing instruction in sports refereeing and officiating; Providing courses of instruction in the field of Sports Management, Physical Training, Sports Medicine, Broadcasting relating to sports and athletics, and Journalism relating to sports and athletics; Providing training in the field of mental conditioning for athletes ~~and others~~ for improved performance in sports and athletic activities, ~~life skills, and other activities~~; Physical fitness training services; Physical fitness conditioning classes; Life skills training, namely, providing mentoring and training to ~~youths, athletes, and others~~ to improve personal character traits, namely, organization, community service, etiquette, sportsmanship, and cultural awareness; Providing information relating to sports, arts and entertainment by means of a web site of the global computer network and electronic media; Organizing, arranging, and staging, sports contests, athletic competitions and events, concerts, and award ceremonies, and general entertainment shows not related to education; Entertainment services, namely, production and distribution of television programs, films, video programs, DVD and video tapes in the fields of sports, and general entertainment not related to education; Publishing Services, namely, publishing of printed publications, books and magazines relating to sports and athletics; Sport Camps; Providing facilities for recreation activities, sports and sports tournaments, and

an array of sporting events, sports and athletic competitions and awards programs not related to education; and Providing club, league, tournament and event functions not related to education, in International Class 41

It is respectfully submitted that this amendment does not require republication as the amendment of the description of goods narrows rather than broadens the scope of the application. This amendment is made pursuant to an Agreement between Applicant and Opposer, who has consented to this amendment. If the amendment is approved by the Board, Opposer, with Applicant's consent, requests that the opposition be withdrawn without prejudice.

**CONCLUSION**

Applicant respectfully requests that this request to amend the application be granted in its entirety.
