NOTICE OF OPPOSITION

Lucite International, Inc., a corporation of Missouri having an address of 7275 Goodlett Farms Parkway, Cordova, Tennessee 38018 (hereinafter “Opposer”), is or will be damaged by the registration of the mark BLUE LUCITE, which is set forth in application Ser. No. 85839405 filed by Karen Y. Hyun (hereinafter “Applicant”), an individual with an address of 1111 S. Grand Avenue, Apt. 509, Los Angeles, CA 90015, and hereby opposes the same.

As grounds for the opposition, Opposer, by its attorneys, avers as follows:

1. On September 14, 1937, the United States Patent and Trademark Office issued Reg. No. 350093 for the mark LUCITE for “thermoplastic synthetic resin material, known as methyl methacrylate, in the form of sheets, rods, and tubes and in powdered and granular form.” A print-out from the United States Patent and Trademark Office’s TSDR database satisfying the requirements of 37 CFR § 2.122(d) for submitting a current status and title copy of the pleaded registration, Reg. No. 350093, is submitted herewith.

2. On August 30, 1955, the United States Patent and Trademark Office issued Reg.

No. 611278 for the mark LUCITE for “synthetic resins in the form of granules for use in the industrial arts and further manufacture.” A print-out from the United States Patent and Trademark Office’s TSDR database satisfying the requirements of 37 CFR § 2.122(d) for submitting a current status and title copy of the pleaded registration, Reg. No. 611278, is submitted herewith.

3. On September 7, 1976, the United States Patent and Trademark Office issued Reg. No. 1047685 for the mark LUCITE for “plastic sheets.” A print-out from the United States Patent and Trademark Office’s TSDR database satisfying the requirements of 37 CFR § 2.122(d) for submitting a current status and title copy of the pleaded registration, Reg. No. 1047685, is submitted herewith.

4. On November 21, 1995, the United States Patent and Trademark Office issued Reg. No. 1936713 for the mark LUCITE-TUF for “acrylic sheet for use in window and lighting applications.” A print-out from the United States Patent and Trademark Office’s TSDR database satisfying the requirements of 37 CFR § 2.122(d) for submitting a current status and title copy of the pleaded registration, Reg. No. 1936713, is submitted herewith.

5. On August 1, 2006, the United States Patent and Trademark Office issued Reg. No. 3124311 for the mark LUCITE for “plastics in the form of suspensions or solutions for use in industrial processes, including such plastics containing acrylic compounds; dispersions of plastics; dispersions of plastics including polymer in monomer; dispersion of plastics including inorganic fillers; unprocessed resins; adhesives, substances and materials for making adhesives; organic glass; unprocessed synthetic resinous plastic materials; unprocessed acrylic resin, synthetic resins, resinoids, acrylic plastisols, resin substitutes in a raw or partly prepared state,

stain and tarnish inhibiting and preventing chemicals and polymers; ink resins; mould release preparations and moulding preparations, moulding powders for use in industry; monomers; polymers for solid support media; resin beads” A print-out from the United States Patent and Trademark Office’s TSDR database satisfying the requirements of 37 CFR § 2.122(d) for submitting a current status and title copy of the pleaded registration, Reg. No. 3124311, is submitted herewith.

6. On August 8, 2006, the United State Patent and Trademark Office issued Reg. No. 3127580 for the mark LUCITE for “showcases, shelves, display shelves and sliding shelves; sign boards of wood or plastics; furniture parts made of glass, artificial glass and plastic, namely, table leaves, countertops, feet for furniture frames; kitchen and bathroom furniture; kitchen worktops; bathroom vanities; furniture worktops; and installations including parts and fittings for all the aforesaid goods.” A print-out from the United States Patent and Trademark Office’s TSDR database satisfying the requirements of 37 CFR § 2.122(d) for submitting a current status and title copy of the pleaded registration, Reg. No. 3127580, is submitted herewith.

7. On October 10, 2006, the United States Patent and Trademark Office issued Reg. No. 3154746 for the mark LUCITE for “lighting instruments and apparatus, namely, light diffusers; bath tubs; shower tubs; shower cubicles; shower panels; shower platforms; sinks; sitz baths; spa baths; and parts and fittings for all the aforesaid goods.” A print-out from the United States Patent and Trademark Office’s TSDR database satisfying the requirements of 37 CFR § 2.122(d) for submitting a current status and title copy of the pleaded registration, Reg. No. 3154746, is submitted herewith.

8. On January 16, 2007, the United States Patent and Trademark Office issued Reg.

No. 3199338 for the mark LUCITE for “window glass, glass panes, common sheet glass for building; aquaria structures, namely, safety glass for use in aquariums; and parts and fittings for all the aforesaid goods.” A print-out from the United States Patent and Trademark Office’s TSDR database satisfying the requirements of 37 CFR § 2.122(d) for submitting a current status and title copy of the pleaded registration, Reg. No. 3199338, is submitted herewith.

9. On February 6, 2007, the United States Patent and Trademark Office issued Reg. No. 3206617 for the mark LUCITE for “plastics in the form of pellets for general industrial purposes; synthetic resins made in the form of sheets, pellets and beads for general industrial purposes; acrylic resin products for general industrial purposes.” A print-out from the United States Patent and Trademark Office’s TSDR database satisfying the requirements of 37 CFR § 2.122(d) for submitting a current status and title copy of the pleaded registration, Reg. No. 3206617, is submitted herewith.

10. Opposer is the owner of Reg. Nos. 350093, 611278, 1047675, 1936713, 3124311, 3127580, 3154746, 3199338 and 3206617 (hereinafter collectively “Opposer’s Registrations”) which are all now incontestable. By making its registrations of record, Opposer has standing to oppose application Ser. No. 85839405 and priority is not in issue.

11. On February 3, 2013, Applicant filed application Ser. No. 85839405 with the United States Patent and Trademark Office seeking to register the mark BLUE LUCITE for “bottoms; jackets; jerseys; short sets; sun protective clothing, namely, shirts, hats, cover ups; wearable garments and clothing, namely, shirts; women’s clothing, namely, shirts, dresses, skirts, blouses; wraps” in International Class 25.

12. Application Ser. No. 85839405 was filed under Section 1(b) of the Trademark Act

based on Applicant's statement, given under oath, of her intention to use the mark BLUE LUCITE on "bottoms; jackets; jerseys; short sets; sun protective clothing, namely, shirts, hats, cover ups; wearable garments and clothing, namely, shirts; women's clothing, namely, shirts, dresses, skirts, blouses; wraps."

13. On information and belief, Applicant did not use the mark BLUE LUCITE in connection with any of the goods designated in application Ser. No. 85839405 prior to its filing date.

14. On information and belief, Applicant has never used the mark BLUE LUCITE in connection with any of the goods specified in application Ser. No. 85839405.

15. On information and belief, Applicant does not have, and never has had, a bona fide intention to use BLUE LUCITE in commerce with any of the goods specified in application Ser. No. 85839405, including "bottoms; jackets; jerseys; short sets; sun protective clothing, namely, shirts, hats, cover ups; wearable garments and clothing, namely, shirts; women's clothing, namely, dresses, skirts, blouses; wraps."

16. On October 22, 2013, application Ser. No. 85839405 was published for opposition.

17. On November 19, 2013, Opposer timely filed a request for a 90-day extension of time to oppose application Ser. No. 85839405. Opposer's request was granted by the Board on that same day.

18. Opposer's LUCITE and LUCITE-TUF marks (hereinafter "Opposer's Marks") were first used in commerce prior to any actual use or constructive use of the BLUE LUCITE mark set forth in application Ser. No. 85839405.

19. Opposer's Marks have been in continuous use in commerce since at least as early as 1937 and are still in use in commerce in connection with the goods set forth in Opposer's Registrations.

20. Since at least as early as 1937, Opposer has spent a significant amount of money and expended a significant amount of resources in the marketing and sale of goods and services bearing Opposer's Marks.

21. Through extensive marketing and promotion and through substantial sales of goods bearing Opposer's Marks, Opposer has established valuable consumer recognition and goodwill in Opposer's Marks.

22. As a result of the foregoing, Opposer's Marks have become well known and famous among customers for the goods set forth in Opposer's Registrations prior to any actual or constructive use of BLUE LUCITE by Applicant.

23. Opposer's Marks set forth in Opposer's Registrations and the BLUE LUCITE mark set forth in application Ser. No. 85839405 are confusingly similar.

24. The goods set forth in Opposer's Registrations and the goods set forth in application Ser. No. 85839405 are closely related.

25. The conditions surrounding the marketing of goods set forth in Opposer's Registrations and the goods set forth in application Ser. No. 85839405 are such that they could be encountered by the same purchasers under circumstances that could give rise to the mistaken belief that the goods come from a common source.

26. Opposer will be damaged by the issuance of this registration. Specifically, the mark set forth in application Ser. No. 85839405 consists of or comprises a mark which so

resembles the marks set forth in Opposer's Registrations as to be likely to cause confusion, or to cause mistake, or to deceive, under Trademark Act Section 2(d), 15 U.S.C. § 1052(d).

27. Registration of Ser. No. 85839405 will damage Opposer under Trademark Act Section 43(c), 15 U.S.C. § 1125(c), in that said registration will dilute the distinctiveness and harm the reputation of Opposer's famous LUCITE and LUCITE-TUF Marks.

28. Registration of the mark set forth in the opposed application should be refused pursuant to Trademark Act Section 2(a), 15 U.S.C. § 1052(a), on the grounds that any use by Applicant of the mark BLUE LUCITE will falsely suggest a connection between Applicant and Opposer named herein, to the damage of Opposer.

29. Opposer further requests that registration of the mark set forth in the opposed application be refused on the basis that Applicant has never had a bona fide intention to use the BLUE LUCITE mark in connection with any of the goods designated in Ser. No. 85839405.

WHEREFORE, Opposer requests that application Ser. No. 85839405 be refused registration.
