**OPPOSER’S MOTION FOR FINAL 60-DAY SUSPENSION WITH CONSENT**

Opposer Top Shop/Top Man Limited, with the consent of Applicants Jill and Richard Card, respectfully requests a final sixty (60) day suspension of the above-captioned opposition proceeding (the “Opposition”). In support of its Motion, Opposer states as follows:

1. The Board’s August 29, 2016 Order provides that all future requests for suspension must include a detailed report setting forth what progress the parties have made towards settlement during the previous period of suspension.
2. Opposer is pleased to report that on October 10, 2016, Opposer and Applicants reached a settlement on all material terms.
3. Opposer and Applicants are now in the process of finalizing the written settlement agreement.
4. Under the current schedule in the Opposition, fact discovery is scheduled to close on October 12, 2016.
5. Given the upcoming deadline and the fact that the contemplated settlement will render the Opposition unnecessary, Opposer is requesting a further suspension to allow the parties to focus their efforts on finalizing the written settlement agreement and obtaining signatures.

6. While Opposer is hopeful that the settlement will be finalized and fully-executed sooner than 60 days from today, Opposer is requesting a 60-day suspension to avoid the need for any future requests for suspension.

7. Applicants consent to this Motion.

Wherefore, Opposer respectfully requests that the Board grant Opposer's Motion and suspend the Opposition for 60 days.
