Applicant's consented motion (filed September 24, 2014) to further suspend this proceeding is granted. Because the parties are negotiating for a possible settlement of this case, proceedings remain suspended up to, and including November 23, 2014, subject to the right of either party to request resumption at any time. *See* Trademark Rule 2.117(c) and TBMP § 605.02.

In the event that there is no word from either party concerning the progress of their negotiations, upon conclusion of the suspension period, proceedings shall resume November 24, 2014 without further notice or order from the Board and shall proceed upon the schedule set forth in applicant's consented motion.

In each instance, a copy of the transcript of testimony together with copies of documentary exhibits, must be served on the adverse party within

thirty days after completion of the taking of testimony. Trademark Rule 2.125.

Briefs shall be filed in accordance with Trademark Rules 2.128(a) and (b). An oral hearing will be set only upon request filed as provided by Trademark Rule 2.129.

If, during the suspension period, either of the parties or their attorneys should have a change of address, the Board should be so informed.<sup>1</sup>
