**NOTICE OF OPPOSITION**

San Mar Corporation, a Washington corporation (“Opposer”), having a principal place of business at 22833 SE Black Nugget Road, Suite 130 Issaquah Washington 98029, believes that it will be damaged by the registration of the mark COTTON DISTRICT, which is the subject of Application Serial No. 85/905,381, published in the Official Gazette on December 31, 2013. Opposer hereby opposes the registration of said mark and requests that registration be refused. As grounds in support of its opposition, Opposer states as follows:

1. Opposer has continuously and regularly used the mark DISTRICT THREADS in connection with various apparel items and various types of bags in interstate commerce and nationwide since at least as early as June 29, 2005. Opposer currently uses the DISTRICT THREADS mark for apparel and bags.

2. Opposer has continuously and regularly used the mark DISTRICT in connection with various apparel items in interstate commerce and nationwide since at least as early as

June 29, 2005. Opposer has continuously and regularly used the mark DISTRICT in connection with various types of bags in interstate commerce and nationwide since at least as early as June 30, 2012. Opposer currently uses the DISTRICT mark for apparel and bags.

3. Opposer has continuously and regularly used the mark WELCOME TO THE DISTRICT for various wholesale, distributorship, and retail services in interstate commerce and nationwide since at least as early as May 31, 2012. Opposer currently uses the WELCOME TO THE DISTRICT mark for wholesale, distributorship, and retail services.

4. Opposer has continuously and regularly used the mark DISTRICT MADE for various apparel items and various types of bags in interstate commerce and nationwide since at least as early as July, 2012. Opposer currently uses the DISTRICT MADE mark for wholesale, distributorship, and retail services.

5. As a result of Opposer's promotion and sale of its products and services under the DISTRICT, DISTRICT THREADS, WELCOME TO THE DISTRICT, and DISTRICT MADE marks, those marks have gained significant recognition and goodwill among the purchasing public.

6. Opposer owns U.S. Trademark Registration No. 3,283,547, issued on August 21, 2007, for the mark DISTRICT THREADS for "Apparel and accessories, namely, tee shirts, sweat shirts, long sleeve shirts, hats, caps, and uniforms; fleece outerwear namely, pullovers, sweat shirts, long sleeve shirts, and beanies; athletic apparel,, namely, shirts" in International Class 25 and "All-purpose carrying bags, backpacks, briefcases, tote-bags, duffel bags, gym bags" in International Class 18. This registration is incontestable pursuant to 15 U.S.C. § 1065 and thus constitutes conclusive evidence of Opposer's exclusive rights for the DISTRICT THREADS mark for the recited goods. The current TSDR and Assignment records for Registration No. 3,283,547 are attached hereto as Exhibit 1 and made a part hereof by this reference.

7. Opposer owns U.S. Trademark Registration No. 3,283,548, issued on August 21, 2007, for the mark DISTRICT for “Apparel, namely tee shirts, polo shirts, long sleeve shirts, and uniforms; fleece outerwear, namely long sleeve shirts, athletic apparel, namely shirts” in International Class 25. This registration is incontestable pursuant to 15 U.S.C. § 1065 and thus constitutes conclusive evidence of Opposer’s exclusive rights for the DISTRICT mark for the recited goods. The current TSDR and Assignment records for Registration No. 3,283,548 are attached hereto as Exhibit 2 and made a part hereof by this reference.

8. Opposer owns U.S. Trademark Registration No. 4,269,274, issued on January 1, 2013, for the mark DISTRICT for “All-purpose carrying bags; backpacks; briefcases; tote-bags; duffel bags; gym bags” in International Class 18. The current TSDR and Assignment records for Registration No. 4,269,274 are attached hereto as Exhibit 3 and made a part hereof by this reference.

9. Opposer owns U.S. Trademark Registration No. 4,332,831, issued on May 7, 2013, for the mark WELCOME TO THE DISTRICT for “Wholesale distributorships, wholesale ordering services, on-line store services, electronic catalog services, mail order catalog services, and web-based catalog services, all featuring apparel, headgear, bags, blankets, and accessories” in International Class 35. The current TSDR and Assignment records for Registration No. 4,332,831 are attached hereto as Exhibit 4 and made a part hereof by this reference.

10. Opposer owns U.S. Trademark Application Serial No. 85/433,409, filed on September 27, 2011, for the mark DISTRICT MADE for “Apparel and accessories, namely, t-shirts, sweat shirts, polo shirts, long sleeve shirts, jackets, pants, sweat pants, uniforms, hats, caps, and neckwear; fleece outerwear, namely, pullovers, sweat shirts, long sleeve shirts, sweat pants, and beanies; athletic apparel, namely, track jackets, track pants, track suits, and shirts” in International Class 25 and “All-purpose carrying bags; backpacks; briefcases; tote-bags; duffel

bags; gym bags” in International Class 18. The current TSDR and Assignment records for Application Serial No. 85/433,409 are attached hereto as Exhibit 5 and made a part hereof by this reference.

11. On April 16, 2013, The Southern Shirt Company, LLC an Alabama limited liability company (“Applicant”), filed an application to register the mark COTTON DISTRICT for “Clothing goods made in whole or in significant part of cotton, namely, t-shirts, tank tops, v-necks, sweatshirts, pullovers, polo shirts, button down shirts, pants, shorts, hats, caps, visors, jackets, short sleeve shirts, long sleeve shirts” in International Class 25, which was assigned Serial No. 85/905,381. The COTTON DISTRICT mark was published in the Official Gazette on December 31, 2013.

12. Prior to Applicant’s filing date of April 16, 2013, Opposer had been using its DISTRICT, DISTRICT THREADS, WELCOME TO THE DISTRICT, and DISTRICT MADE marks on clothing, bags, and various retail services for years.

13. Opposer’s registration for its DISTRICT, DISTRICT THREADS, and WELCOME TO THE DISTRICT marks have earlier filing dates and an earlier priority dates than Applicant’s application for the mark COTTON DISTRICT; hence, Opposer’s registrations have priority over Applicant’s application.

14. Opposer’s application for its DISTRICT MADE mark has an earlier filing date and an earlier priority date than Applicant’s application for the mark COTTON DISTRICT; hence, Opposer’s application has priority over Applicant’s application.

15. The goods on which Applicant intends to use the mark COTTON DISTRICT, as evidenced by Applicant’s application, are identical or highly related to the goods and services on which Opposer uses its DISTRICT, DISTRICT THREADS, WELCOME TO THE DISTRICT, and DISTRICT MADE marks, as evidenced by Opposer’s registrations and application.



16. The mark COTTON DISTRICT, as evidenced by Applicant's application, is very similar in sight, sound, and meaning to Opposer's DISTRICT, DISTRICT THREADS, WELCOME TO THE DISTRICT, and DISTRICT MADE marks.

17. The similarity of the mark COTTON DISTRICT to Opposer's DISTRICT, DISTRICT THREADS, WELCOME TO THE DISTRICT, and DISTRICT MADE marks is compounded by the fact that Applicant has disclaimed the word "COTTON" in its mark.

18. The mark COTTON DISTRICT, as evidenced by Applicant's application, so resembles each and all of Opposer's DISTRICT, DISTRICT THREADS, WELCOME TO THE DISTRICT, and DISTRICT MADE marks as to be likely to cause confusion, mistake, or deception, when used in connection with identical or highly related goods and services, within the meaning of Section 2(d) of the Lanham Trademark Act.

19. The mark COTTON DISTRICT, with "COTTON" disclaimed, includes within it all of Opposer's DISTRICT mark, and as such, misleads consumers into believing the goods on which Applicant intends to use the COTTON DISTRICT mark are a portion, extension, expansion, or collaboration with Opposer's DISTRICT products and related services, or are otherwise associated with Opposer, when they are not.

20. The addition of the disclaimed and descriptive word COTTON attached onto Opposer's DISTRICT mark does not distinguish Applicant's Mark, and in fact makes confusion *more* likely because the majority of Opposer's apparel products are made of cotton.



Accordingly, Opposer will be damaged by the registration Applicant seeks because the registration will assist and support Applicant in the confusing and misleading use of the mark COTTON DISTRICT and will give color of exclusive statutory rights to Applicant in violation and derogation of Opposer's prior rights.

WHEREFORE, Opposer prays that the opposition be sustained and that registration to Applicant be refused.


