- 5. Smart Dog University avers that Innotek's Application Serial No. 75/608,700 ("Innotek Application") speaks for itself, and Smart Dog University denies any allegations inconsistent with the Innotek Application.
- 6. Smart Dog University avers that the Trademark Status and Document Retrieval ("TSDR") electronic database records of the USPTO speak for themselves, and Smart Dog University denies any allegations inconsistent with those records.
- 7. Paragraph 7 contains legal conclusions to which no response is required. To the extent that a response is required, Smart Dog University denies the allegations in Paragraph 7.
- 8. Paragraph 8 contains legal conclusions to which no response is required. To the extent that a response is required, Smart Dog University denies the allegations in Paragraph 8.
- 9. Smart Dog University lacks sufficient information at this time to admit or deny the allegations in Paragraph 9, and therefore denies same.

- 27. Smart Dog University avers that its Application Serial No. 86/186,257 ("Smart Dog University Application No. 2") speaks for itself, and denies any allegations inconsistent with that application.
- 28. Smart Dog University avers that Smart Dog University Application No. 2 speaks for itself, and denies any allegations inconsistent with that application.
- 29. Smart Dog University lacks sufficient information at this time to admit or deny the allegations in Paragraph 29, and therefore denies same.
- 30. Paragraph 30 contains legal conclusions to which no response is required. To the extent that a response is required, Smart Dog University denies the allegations in Paragraph 30.
  - 31. Smart Dog University denies the allegations in Paragraph 31.
  - 32. Smart Dog University denies the allegations in Paragraph 32.
  - 33. Smart Dog University denies the allegations in Paragraph 33.
  - 34. Smart Dog University denies the allegations in Paragraph 34.

#### **DEFENSES**

- 40. There is no likelihood of confusion, mistake or deception between Smart Dog University's mark and the Opposer's mark.
- 41. There is no actual confusion between Smart Dog University's mark and the Opposer's mark, or with respect to customers or others.
- 42. There is no deceptiveness or false suggestion of a connection between Smart Dog University's mark and the Opposer's mark.
  - 43. Innotek has abandoned the mark as registered in the Innotek Registration.
  - 44. The Innotek Registration is generic.
  - 45. The equitable defense of laches bars Innotek's Notice of Opposition.
  - 46. The equitable defense of estoppel bars Innotek's Notice of Opposition.
  - 47. The defense of acquiescence bars Innotek's Notice of Opposition.
- 48. Any opposition related to Application Serial No. 86/186,257 or Application Serial No. 86/117,460 is premature and not ripe unless and until registrations issue.

## **COUNTERCLAIM**

49. Pursuant to 15 U.S.C. § 1064(3), 37 CFR § 2.106(b)(2), and Section 313 of the Trademark Trial and Appeal Board Manual of Procedure, Smart Dog University files this counterclaim to cancel Innotek's Registration No. 2,411,822, and avers as follows:

- 50. Smart Dog University has a direct and personal stake in the outcome of these proceedings, has an equal right to use the SMART DOG UNIVERSITY mark, and believes it will be damaged in the event that Innotek's Registration is not cancelled.
- Application No. 1, with U.S. Ser. No. 86/092,854, for the mark SMART DOG UNIVERSITY used in connection with: "Education services, namely, providing live and on-line courses, classes and instruction to trainers and pet owners in the field of pet training, pet exercise, and pet obedience services; Education services, namely, providing mentoring, tutoring, classes, seminars and workshops in the field of pet training, pet exercise, and pet obedience; Education services, namely, providing courses, classes and instruction in the fields of pet training, pet exercise, and pet obedience; Pet exercise services; Pet obedience training services; Pet training services; Providing information and advice in the field of pet training" in International Class 041. Printed information from the Trademark Status and Document Retrieval ("TSDR") electronic database records of the USPTO showing the current status and title of Smart Dog University Application No. 1 is attached as Exhibit 1.
- 52. Smart Dog University is owned and operated by Laurie Luck, who has been training and working with dogs and other companion animals for approximately twenty years.

  Ms. Luck is a highly accomplished trainer who fully embraces scientifically-based, force-free, positive reinforcement training for companion animals. Ms. Luck has a Master of Arts in psychology, has served as President of the Certification Council for Professional Dog Trainers ("CCPDT"), was certified by the CCPDT as a Certified Professional Dog Trainer and is a graduate of and faculty member for the Karen Pryor Academy for Animal Training and Behavior ("Karen Pryor Academy").

- 53. The Karen Pryor Academy is an educational institution and a pioneer in the development and use of force-free training methods for dogs and other companion animals. The Karen Pryor Academy understands the history and pit falls of punishment and aversive methods in training, and finds force-free, positive reinforcement methods of training to be more powerful and effective in every way. Consistent with its philosophy, the Karen Pryor Academy does not use and does not agree with the use of electronic collars, prong collars, choke collars, or other aversive training tools.
- 54. Ms. Luck and Smart Dog University wholly embrace force-free, positive reinforcement based training methods, and consistent with the Karen Pryor Academy, do not use and do not agree with the use of electronic collars, prong collars, choke collars, or other aversive training tools. Trainers who are interested in attending the Karen Pryor Academy seek out Ms. Luck with Smart Dog University to serve as a mentor because of her extensive experience, reputation, and dedication to force-free training methods. Smart Dog University and Ms. Luck also offer seminars and speaking engagements nationwide on force-free, positive reinforcement based training topics.
- 55. Smart Dog University offers group and private dog training in Maryland, with some of Smart Dog University's students traveling from out of state, including from Virginia, the District of Columbia, Pennsylvania, and Delaware.
- 56. Smart Dog University's Application No. 1 was published for opposition on April 1, 2014, and Innotek filed an opposition.
- 57. On December 18, 1998, the application with Serial No. 75/608,700 ("Innotek Application") was filed and matured into the Innotek Registration, U.S. Reg. No. 2, 411,822 ("Innotek Registration"), with a registration date of December 12, 2000. Printed information

from TSDR electronic database records of the USPTO showing the current status and title of Innotek's SMART DOG registration is attached as <a href="Exhibit 2">Exhibit 2</a>.

- 58. The description of goods for the mark SMART DOG in the Innotek Registration is as follows: "Electrical animal behavior training and control systems, namely remote training systems consisting of electrical radio frequency transmitters and remote controlled electrical receiver animal collars; electrical barking control animal collars; electronic pet containment systems consisting of electrical transmitters and electrical receiver animal collars; electrically controlled pet doors consisting of an electrical receiver and door actuator; and electrical animal tracking and locating systems consisting of electrical receivers and electrical animal transmitter collars" in Class 009.
  - 59. The word "DOG" is disclaimed in the Innotek Registration.
- 60. Since the time that Innotek filed the Innotek Application and received the Innotek Registration, the word "SMART" has subsequently taken on a generic meaning as it related to electronics, including as to the goods described in the Innotek Registration.
- 61. The current edition of the Collins English Dictionary defines "smart", inter alia, as "operating as if by human intelligence by using automatic computer control", as reflected in Exhibit 3.
- 62. Numerous third parties who deal with or in electronic goods and services use SMART to describe their goods and services.
- 63. The most salient example of the use of SMART to describe goods or services related to electronics relates to the generic term "smartphone," defined in the current edition of the Collins English Dictionary as "a mobile telephone with computer features that may enable it

to interact with computerized systems, send e-mails, and access the web," as reflected in <u>Exhibit</u> 4.

- described in Innotek's Registration, on August 24, 2005, Perimeter Technologies, Inc. filed an application for the word mark SMART ZONE, which was assigned Serial No. 78/699,652 that matured unopposed into Registration No. 3,132,603 ("Perimeter Technologies Registration"), with a registration date of August 22, 2006. Printed information from the TSDR electronic database records of the USPTO showing the current status and title of Perimeter Technologies, Inc.'s SMART ZONE registration is attached hereto as Exhibit 5.
- 65. The Perimeter Technologies Registration disclaims the term "smart" and contains a description of goods of a "feature of an electronic animal containment system, namely, a transmitter and receiver used as an electronic pet deterrent where the receiver detects a radio frequency and activates within the coverage area."
- 66. Based on information and belief, Innotek has been modifying the use of its SMART DOG mark over the years in response to the fact that its SMART DOG mark has become generic. For instance, a specimen filed by Innotek in 2006 shows how Innotek used the mark SMART DOG on its product cover, as reflected in <a href="Exhibit 6">Exhibit 6</a>.
- 67. By 2010, Innotek changed its packaging to link the SMART DOG words with a curve design to the mark INNOTEK, as shown in a specimen filed by Innotek in 2010 and as reflected in Exhibit 7.
- 68. A June 2014 Google search of Innotek's website, www.innotek.net, for the words "smart dog" turn up only two results, neither of which contain SMART DOG, but rather the term

"UltraSmart" for an "UltraSmart Probe Kit" and an "UltraSmart Contain 'N' Train", as reflected in Exhibit 8.

- 69. Based on widespread use of the term "smart" as it relates to electronics including the goods described in the Innotek Registration, Innotek's SMART DOG mark is now generic.
- 70. Based on information and belief, Innotek has failed to use the SMART DOG mark as registered, has no intent to resume use of the SMART DOG mark, and has therefore abandoned said mark.
- 71. In the event that Innotek's SMART DOG mark is deemed not to be generic and Innotek is deemed not to have abandoned said mark for failure to use the mark as registered, Innotek's rights as to the SMART DOG mark are very narrow, as said mark would be merely highly descriptive, and no likelihood of confusion exists between Innotek's SMART DOG mark and Smart Dog University's SMART DOG UNIVERSITY mark.
- 72. As evidence of how narrow Innotek's SMART DOG mark is, in addition to Perimeter Technologies, Inc.'s registration reflected in <a href="Exhibit 4">Exhibit 4</a>, dozens of third parties who deal with pet products and related goods and services have federally registered trademarks that contain SMART as part of their mark.
- 73. As reflected in Exhibit 9, Reg. No. 1, 559,337 was issued to Pacific Coast Distributing, Inc., dba Petsmart, for the mark PETSMART in conjunction with wholesale distributorship and retail pet supply store services in IC Class 42.
- 74. As reflected in Exhibit 10, Reg. No. 1,840,778 was issued to Smart & Final Stores Corporation for the mark SMARTY in conjunction with wet and dry dog and cat food, dog biscuits, and cat liter in IC Class 31.

- 75. As reflected in Exhibit 11, Reg. No. 2,776,584 was issued to Happy Puppy Kindergarten, Inc. for the mark PUPPYSMARTS in conjunction with prerecorded video cassettes, digital video discs and compact discs on the subject of animal obedience and behavioral training in IC Class 9.
- 76. As reflected in Exhibit 12, Reg. No. 3,102,115 was issued to The Iams Company for the mark IAMS SMART PUPPY in conjunction with foodstuffs for dogs in IC Class 31.
- 77. As reflected in Exhibit 13, Reg. No. 3,156,061 was issued to Petsmart Store Support Group, Inc. for the mark SMART PETS in conjunction with pet training services in IC Class 41.
- 78. As reflected in Exhibit 14, Reg. No. 3,160,912 was issued to Worldwise, Inc. for the mark SMARTYKAT in conjunction with pet toys, in IC Class 28.
- 79. As reflected in Exhibit 15, Reg. No. 3,196,335 was issued to Petsmart Store Support Group, Inc. for the mark PETSMART with a ball and bounce design, in conjunction with retail store services and related services in IC Class 35, educational services and related services in IC Class 41, pet boarding, kennel, daycare, and related services in IC Class 43, pet grooming and related services in IC Class 44, and pet adoption and related services in IC Class 45.
- 80. As reflected in Exhibit 16, Reg. No. 3,220,843 was issued to Cargill, Inc. for the mark NATURE SMART in conjunction with animal feed in IC Class 31.
- 81. As reflected in Exhibit 17, Reg. No. 3,247,549 was issued to Sunshine Mills, Inc. for the mark EXTRA SMART! in conjunction with foodstuffs for animals in IC Class 31.

- 82. As reflected in Exhibit 18, Reg. No. 3,330,768 was issued to Doane Pet Care Company for the mark SMART BITES in conjunction with pet foods, including pet treats, in IC Class 31.
- 83. As reflected in Exhibit 19, Reg. No. 3,227,779 was issued to Midwestern Pet Foods, Inc. for the mark SMART REWARDS in conjunction with edible pet treats in IC Class 31.
- 84. As reflected in Exhibit 20, Reg. No. 3,237,319 was issued to Bergan, LLC for the mark SMART STORAGE in conjunction with pet food containers in IC Class 21.
- 85. As reflected in Exhibit 21, Reg. No. 3,357,904 was issued to The Iams Company for the mark BREEDSMART in conjunction with foodstuffs for animals in IC Class 31, for providing a website via a global computer network featuring information in the field of dog training tips in IC Class 41, and for providing a website via a global computer network featuring information in the field of dog care namely nutritional advice and breeding in IC Class 44.
- 86. As reflected in Exhibit 22, Reg. No. 3,357,102 was issued to Tracy M. St. Pierre for the mark HOW SMART IS YOUR DOG? in conjunction with pet toys, in IC Class 28.
- 87. As reflected in Exhibit 23, Reg. No. 3,341,307 was issued to Petsmart Store Support Group, Inc. for the mark THAT'S SMART in conjunction with retail store and related services in IC Class 35, educational and related services in IC Class 41, pet boarding and related services in IC Class 43, pet grooming and related services in IC Class 44, and pet adoption and related services in IC Class 45.
- 88. As reflected in Exhibit 24, Reg. No. 3,326,238 was issued to Katherine ONieal for the mark HAPPY, CLEAN AND SMART in conjunction with boarding for animals and pet day care services in IC Class 43.

- 89. As reflected in Exhibit 25, Reg. No. 3,399,613 was issued to Christopher Onthank for the mark DOG GONE SMART in conjunction with pre-recorded DVDs and videos featuring dog training instruction in IC Class 9, seat covers for vehicles in IC Class 12, pet leashes, pet collars, dog jackets and fabric crate pads for use in pet training in IC Class 18, dog beds and crate pads in IC Class 20, retail store services featuring pet supplies in IC Class 35, dog training services and related services in IC Class 41, canine center services and related services in IC Classes 43 and 44.
- 90. As reflected in Exhibit 26, Reg. No. 3,420,018 was issued to Petstages, Inc. for the mark SMART PAW in conjunction with plastic teething, chewing and clawing toys for dogs, cats and birds in IC Class 28.
- 91. As reflected in Exhibit 27, Reg. No. 3,453,791 was issued to Premier Pet Products, LLC for the mark SMART BOWL in conjunction with pet feeding dishes in IC Class 21.
- 92. As reflected in Exhibit 28, Reg. No. 3,467,978 was issued to Christopher Onthank for the mark DOG GONE SMART in conjunction with pamphlets and handouts on the subject of dog training in IC Class 16.
- 93. As reflected in Exhibit 29, Reg. No. 3,589,265 was issued to S&E Marketing, LLC for the mark SMART FENCES in conjunction with online retail store services featuring pet training products, specifically wireless pet training and containment systems in IC Class 35.
- 94. As reflected in <u>Exhibit 30</u>, Reg. No. 3,640,248 was issued to Food Lion, Inc. for the mark SMART OPTION in conjunction with, inter alia, pet food in IC Class 31.
- 95. As reflected in Exhibit 31, Reg. No. 3,678,351 was issued to Guard-A-Kid Franchising Corp. for the mark SMART I.D. and design, in conjunction with an electronic

database containing identification and medical information of children, people and pets to aid in recovery of missing children, people and pets in IC Class 9.

- 96. As reflected in Exhibit 32, Reg. No. 3,758,436 was issued to Natural Polymer International Corp. for the mark SIMPLY SMART in conjunction with cat and dog treats and related products in IC Class 31.
- 97. As reflected in Exhibit 33, Reg. No. 3,782,318 was issued to Sergeant's Pet Care Products, Inc. for the mark SMARTDIPS in conjunction with rawhide pet treats in IC Class 18.
- 98. As reflected in Exhibit 34, Reg. No. 3,797,509 was issued to Schlotterbeck & Foss Company for the mark SMART PUP in conjunction with dietary supplements for animals and pets in IC Class 5.
- 99. As reflected in Exhibit 35, Reg. No. 3,848,738 was issued to Petsmart Store Support Group, Inc. for the mark PETSMART. WE LOVE TO SEE HEALTHY, HAPPY PETS in conjunction with retail and on-line store services featuring pet food, pet supplies and pet accessories in IC Class 35.

- 140. As reflected in Exhibit 76 and the website www.onesmartk9.com, One Smart K9 in Blacklick, Ohio uses the mark "One Smart K9" in conjunction with dog training and boarding services.
- 141. As reflected in Exhibit 77 and the website www.smartdogsdogtraining.com, Smart Dogs Dog Training in California uses the mark "Smart Dogs Dog Training" in conjunction with dog training services.

- 142. As reflected in Exhibit 78 and the website www.smartdogsolutions.com, Smart Dog Solutions in Hamburg, New York uses the mark "Smart Dog Solutions" in conjunction with dog training services.
- 143. These registrations, applications and website printouts demonstrate that, even assuming Innotek's SMART DOG mark is not deemed to be generic, Innotek's rights as to the SMART DOG mark would be very narrow, as said mark is merely highly descriptive and lacks secondary meaning and is in no way distinctive of Innotek's goods.
- Smart Dog University's SMART DOG UNIVERSITY. Even assuming there were a likelihood of confusion between Innotek's SMART DOG mark and Smart Dog University's SMART DOG UNIVERSITY mark, based on information and belief, Innotek has abandoned its SMART DOG mark, having known of Smart Dog University's SMART DOG UNIVERSITY mark and the other marks above, and having failed to police its rights to its SMART DOG mark.
- 145. Based on information and belief, Innotek knew of Smart Dog University and its SMART DOG UNIVERSITY mark since at least 2006, when Smart Dog University filed an application for the SMART DOG UNIVERSITY mark with a logo, and which was assigned Serial No. 78/830,738. Printed information from the TSDR electronic database records of the USPTO showing the current status and title of that Smart Dog University application is attached hereto as Exhibit 79.
- 146. As a result of Innotek's failure to enforce its claimed rights to the SMART DOG mark, to the extent that it has such rights, against Smart Dog University and other third parties, Innotek has abandoned said mark.
  - 147. Based on the above, Innotek's Registration should be cancelled.

Therefore, Smart Dog University prays that the Notice of Opposition be dismissed with prejudice, and also respectfully requests that U.S. Reg. No. 2,411,822 be cancelled.


