

Oregon Honey Products LLC d/b/a Nectar Creek Honeywine ("**Nectar Creek**") and Brood Soda, LLC ("**Brood Soda**") stipulate and agree as follows:

1. Opposition No. 91217486 shall be dismissed with prejudice.
2. Brood Soda shall not contest the registration of <**Brood**> by Nectar Creek pursuant to its application under Serial Number, 86229370.
3. Nectar Creek shall file a Statement of Use pursuant to its application under Serial Number, 86229370.
4. Nectar Creek shall assign its registration of <**Brood**> and rights to use <**Brood**> to Brood Soda upon the mark being registered and Brood Soda shall license the mark, <**Brood**>, to Nectar Creek to use in the manufacturing, marketing, sale, and advertising of Brood mead. Said license has been executed by the parties contingent upon the other matters set forth in this Stipulation being completed.
5. Nectar Creek and Brood Soda shall share equally in the cost of preparing this Stipulation and the aforesaid license by the attorneys for Nectar Creek and Brood Soda shall pay Nectar Creek for ½ of all reasonable attorney's fees incurred by Nectar Creek therefrom (not to exceed \$1,500 total, ½ of which shall be paid by Brood Soda to Nectar Creek).
