**MOTION ON CONSENT TO AMEND APPLICATION  
SERIAL NO. 86/157,616 AND TO SUSPEND PROCEEDINGS**

Pursuant to Rule 2.133 of the Trademark Rules of Practice, Applicant respectfully requests that the above-captioned application be amended by adding the bolded language “; **none of the foregoing goods including entertainment software or relating to video games**” to the end of the description of goods, and by deleting the following goods: “electronic interactive board games for use with external monitor” and “hand held units for playing electronic games,” so the amended description of goods should now read:

DRY ERASE BOARDS AND ERASERS, MARKERS, A TIMER AND T-SHIRTS;  
GAMING PAPER, NAMELY, PAPER PRINTED WITH REGULAR GRID AND  
HEXAGON PATTERNS FOR USE IN PLAYING WAR GAMES, ROLE PLAYING  
GAMES AND MINIATURE GAMES; ~~HAND HELD UNITS FOR PLAYING  
ELECTRONIC GAMES~~; INFANT DEVELOPMENT TOYS; INFANT TOYS;  
MEMORY GAMES; PARLOUR GAMES; PLAYING CARD GAME ACCESSORIES,  
NAMELY, PLAYING CARD CASES, PLAYING CARD HOLDERS, MATS FOR USE  
IN CONNECTION WITH PLAYING CARD GAMES, PLAYING CARD SHUFFLING  
DEVICES AND DICE; PLAYING CARDS AND CARD GAMES; PLUSH TOYS;  
POSITIONABLE PRINTED TOY FIGURES FOR USE IN GAMES; ROLE PLAYING  
GAMES; SQUEEZABLE SQUEAKING TOYS; SQUEEZE TOYS; STUFFED AND  
PLUSH TOYS; **NONE OF THE FOREGOING GOODS INCLUDING  
ENTERTAINMENT SOFTWARE OR RELATING TO VIDEO GAMES** in


