Applicant consented to this extension via email on October 21, 2016.

The parties are engaging in settlement discussions therefore this request is made in good faith and not merely for delay. The parties have drafted a written settlement agreement and have spent the current extension period negotiating one last point. As of September 20, 2016, the time of the last extension request, the agreement was under review by Applicant. On September 28, 2016, Opposer's attorneys followed-up with Applicant's Attorneys.
