NOTICE OF OPPOSITION

Cerruti 1881 s.a.s, a Societe par Actions Simpliffee, organized under the laws of France with its place of business at 3, Place de la Madeleine, Paris, F-75008, France ("Opposer"), believes it will be damaged by registration of Application No. 86204704 for GIORGIO CERRUTI, and therefore opposes same. Opposer obtained an extension of time to oppose registration of GIORGIO CERRUTI to and including December 10, 2014. As grounds for opposition, Opposer states, as follows:

1. Mainland Exchange, Inc., a California Corporation ("Applicant"), filed Application No. 86204704 for GIORGIO CERRUTI (the "Application" or "Applicant's Mark") on February 26, 2014, based on claimed actual use in commerce beginning on February 26, 2014.
2. The Application was published in the Official Gazette on August 12, 2014, and covers "Dress pants; Dress shirts; Men's suits; Sport coats; Ties; Tuxedos" in International Class 25.

3. Applicant claims a first use in commerce date of February 26, 2014 for the goods in the Application.

4. At least as early as 1997, in the United States, Opposer has designed, manufactured, marketed, distributed, licensed and sold luxury ready-to-wear fashions, apparel, fragrances, sportswear, leather goods, watches, and accessories under its CERRUTI, and CERRUTI 1881 Marks (Opposer's CERRUTI Marks or the CERRUTI Marks).

5. In the United States, Opposer owns the following registrations and application for its CERRUTI Marks, the first use and filing dates of which precede Applicant's claimed first use in commerce date. Opposer's CERRUTI Marks include:

Status and title copies of Opposer's registrations are attached as Exhibit A.

6. Opposer owns registrations and common law trademark rights that cover Class 25 goods and related goods in Class 3 and Class 14 that are either identical or closely related to the goods in the Application.

7. Opposer's registrations and its pending application predate the first use in commerce and/or filing date of the Application.
8. Opposer's registrations and application remain valid and owned in the name of Opposer, and Opposer has standing to bring this opposition.
9. The Application covers goods that are identical and/or closely related to the goods covered by Opposer's CERRUTI Marks.
10. Applicant's Mark includes "CERRUTI" as its most prominent feature which is identical to Opposer's CERRUTI Marks and is so similar in sound, appearance and connotation as to create a likelihood of confusion with Opposer's CERRUTI Marks.
11. Opposer's CERRUTI Marks have a priority date as early as 1997, which long predates Applicant's February 26, 2014 first use in commerce and filing dates and any claim of priority by Applicant. Opposer's CERRUTI Marks therefore have priority over Applicant's Mark.
12. Because Applicant's Mark (a) is confusingly similar to Opposer's CERRUTI Marks; (b) covers goods identical and/or closely related to the goods covered by the registrations and other trademark rights for Opposer's CERRUTI Marks; and (c) is junior to Opposer's CERRUTI Marks, Applicant's Mark so resembles Opposer's CERRUTI Marks as to be likely to cause confusion and mistake, or deceive consumers as to source, sponsorship, or affiliation of the parties and their respective goods, all in violation of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).
13. The grant of registration to Applicant of its GIORGIO CERRUTI mark in Application No. 86204704 would create statutory rights in Applicant in violation and derogation of the established prior rights of Opposer, resulting in harm, detriment and damage to Opposer.

WHEREFORE, Opposer Cerruti 1881 s.a.s. prays that Application No. 86204704 be rejected, that no registration be issued to Applicant Mainland Exchange, Inc., and that this opposition be sustained in Opposer's favor.
