NOTICE OF OPPOSITION

Opposer D1 Sports Holdings, LLC., a Tennessee limited liability company with its principal place of business at 7115 South Spring Drive, Franklin, Tennessee 37067, believes it will be damaged by registration of the mark "D1X LACROSSE & Design ("Applicant's Mark") as applied for in Serial No. 85/915,737 filed on April 26, 2013 by Applicant D1X Lacrosse, LLC ("Applicant").

As grounds for opposition, Opposer alleges as follows:

- 1. On information and belief, Applicant is a Michigan limited liability company with a mailing address at P.O. Box 341, Farmington, Michigan 48332-0341.
- 2. Applicant filed Application Serial No. 85/915,737 on April 26, 2013, seeking registration of Applicant's Mark for "providing lacrosse camp and lacrosse clinic services; arranging and conducting athletic competitions to measure lacrosse players for speed, skill and

strength in the field lacrosse; sports instructions services in the field of lacrosse" in International Class 41.

- 3. On August 20, 2013, the Examining Attorney for Applicant's Mark issued an Office Action refusing to register Applicant's Mark based on a likelihood of confusion with Opposer's marks **D1** in U.S. Registration No. 2,877,559 and **D1 & Design** in U.S. Registration No. 4,051,175 (the "Cited Marks"). True and correct copies of U.S. Reg. Nos. 2,877,559 and 4,051,175 are attached as Exhibits 1 and 2, respectively.
- 4. Opposer is the owner of incontestable U.S. Registration No. 2,877,559 for the mark **D1** for "sports training in the fields of football, baseball, hockey, basketball and soccer" in Class 41. The second registration cited by the Examining Attorney for Applicant's Mark, U.S. Registration No. 4,051,175, for the mark **D1 & Design**, cover "management of wellness centers for others" in Class 35.
- 4. On February 28, 2014, in its response to the Office Action, Applicant, among other things, amended its application to modify the identification of services to read as follows:

providing lacrosse camp and lacrosse clinic services to prepare student athletes with the skills to try out for Division 1 lacrosse programs; arranging and conducting athletic competitions to measure lacrosse players for speed, skill and strength in the field of lacrosse to assess skills for potential acceptance into Division 1 lacrosse programs; sports instructions—services in the field of lacrosse to prepare student athletes with the skills to try out for Division 1 lacrosse programs.

(Additions and deletion to the amended identification of services are underlined above). The amendments to the identification of services were accepted on March 4, 2014.

5. Applicant's Mark was published in the *Official Gazette* on August 19, 2014.

- 6. In addition to the Cited Marks, Opposer is the owner of U.S. Registration No. 4,051,176 for the mark **D1** for "management of wellness centers for others" in Class 35 and "physical therapy" in Class 44; (This registration, together with the Cited Marks, are referred collectively herein as "Opposer's Registered Marks.") A true and correct copy of Opposer's Reg. no. 4,051,176 is attached as Exhibit 3. The date of first use in commerce for all of Opposer's Registered Marks is March 1, 2003.
- 7. Opposer's Registered Marks are valid, subsisting, uncancelled and conclusive evidence of Opposer's exclusive right to use the mark **D1** in commerce and/or in connection with the services specified in the registrations for Opposer's Registered Marks. True and correct copies of the registrations for Opposer's Marks are attached hereto as Exhibits A-1, A-2 and A-3, and incorporated by reference as though fully set forth herein.
- 8. Opposer is also the owner of the following marks (collectively, "Opposer's Pending Marks") which are the subject of pending applications, and all but one of which to date were already approved for publication.

- 9. Since at least as early as March 1, 2003, Opposer adopted and has continuously used its D1 word and design marks in connection with sports training and other related goods and services. Opposer has used its D1 word and design marks since at least 9 ½ years prior to Applicant's alleged first use in commerce and for at least 10 years prior to Applicant's filing of the subject Application.
- 10. Opposer has invested substantial amounts of time, effort and money in developing, marketing, promoting and protecting its D1 marks in the field of sports training and related goods and services. As a result, Opposer's D1 Marks are widely recognized in the sports training industry and by other relevant consumers. As such, in addition to the protection afforded Opposer by its federal trademark registrations for D1, it has non-registered statutory and common law rights in and to the mark D1.
- 11. Applicant has no license, consent or permission from Opposer to use or register the mark D1.
- 12. Applicant's Mark so resembles Opposer's Registered Marks and Opposer's Pending Marks and covers related services that it is likely to cause confusion, or to cause mistake or to deceive within the meaning of Section 2(d) of the Trademark (Lanham) Act of 1946, 15 U.S.C. § 1052(d); and more particularly, Applicant's Mark and use thereof are likely to cause

confusion in, or to cause mistake by, or to deceive the trade and purchasing public into believing that the services in Serial No. 85/915,737 originate with or are affiliated with Opposer, or otherwise are authorized, licensed or sponsored by Opposer.

- 13. Previously, on or about July 27, 2012, Applicant filed an application for the mark "D1X," Serial. No. 85/685,298 for "sports training services, namely, lacrosse training services." Applicant abandoned that application on June 21, 2013, after failing to respond to the Examining Attorney's Office Action, which refused registration based on a likelihood of confusion with two marks, including U.S. Registration 4,051,175 owned by Opposer.
- 14. By reason of the foregoing, Opposer will be gravely damaged by the registration of Applicant's Mark for the services in Serial No. 85/915,737, because registration of that mark would be in violation of Opposer's trademark rights.

WHEREFORE, Opposer prays that this Notice of Opposition be sustained in favor of Opposer and that Serial No. 85/915,737 be denied registration.


