1. On or around February 20, 2015, Opposer FirstBank Holding Company (“Opposer”) filed a Notice of Opposition in this matter.
2. Under the Rules governing this matter, Applicant’s deadline to file an Answer or otherwise plead is April 1, 2015.
3. Applicant and Opposer have been in good faith settlement negotiations for several months and anticipate that a settlement agreement will be reached in the near future.
4. Applicant desires to avoid engaging in further litigation in the event that the parties are able to resolve this matter through settlement.
5. On March 24, 2015, Opposer’s counsel informed Applicant’s counsel that Opposer does not object to a 60-day extension for Applicant to answer or otherwise plead.
