**Motion for an Extension of Time for Applicant To Respond to Opposer's Motion for Judgment and To Dismiss**

day or two, at which point Applicant hopes to be in a position to supersede this motion with the filing of a *Stipulated Consent* Motion to extend the time to respond and to otherwise secure the extension and resetting of deadlines and dates requested herein.
