CONSENTED MOTION TO FURTHER SUSPEND PROCEEDINGS

Applicant, through its attorneys, hereby moves on consent of counsel for Opposer to further suspend the above-captioned opposition proceedings for an additional sixty-day (60 day) period.

The proceedings are currently suspended to permit the parties to engage in settlement discussions, and the proceedings are due to resume on January 14, 2017. As noted previously, Applicant's Motion for Summary Judgment filed on May 11, 2016 has been fully briefed. Additionally, as noted previously, Opposer has filed a Cross-motion for Summary Judgment (the "Cross-Motion"). Under the prior suspension order, dated July 15, 2016, Applicant's time to file its response to the Cross-Motion was set for thirty (30) days after resumption of these proceedings.

The parties request that these proceedings be further suspended for an additional sixty day period, subject to the right of either party to request resumption at any time, to allow the parties to continue to engage in settlement discussions. The parties also agree and make a consented motion to request that Applicant have thirty days after resumption of these proceedings to respond to the Cross-Motion.

Consent for this motion was granted by counsel for Opposer via telephonic conversations on January 11 and January 12, 2017, and subsequently memorialized through email.

This motion relies on good cause, and is not brought for the purposes of delay.
