NOTICE OF OPPOSITION

This opposition is made to the application of Applicant, Undies E-Commerce LLC, for registration of the mark undies.com in Application Serial No. 86296717, published on May 5, 2015 (“Applicant’s Mark”). Opposer, ETAM, has obtained an extension of time to oppose, to July 4, 2015.

Opposer believes it will be damaged by the registration of Applicant’s Mark, and hereby opposes the same. As grounds for its opposition, Opposer states and alleges as follows:

1. Opposer is a joint stock company organized under the laws of France, with an address of 57 - 59, rue Henri Barbusse, 92110 Clichy, France.
2. On information and belief, Applicant is a limited liability company organized under the laws of New York, with an address of 7th Floor, 1372 Broadway, New York, New York 10018.
3. Active in more than 40 countries, with more than 4,100 sales outlets and 19,900

employees, Opposer is a major player in women's fashion around the world through its three brands, Etam, 1.2.3 and Undiz, which cover complementary markets and offer well-recognized expertise in lingerie and beauty, clothing and accessories.

4. Opposer has used and registered its trademark shown to the right in connection with its wide variety of products in countries around the world, and is also the owner of United States Trademark Registration No. 4270721 for the mark, issued on January 8, 2013, based on an application filed on October 28, 2011, for goods identified in International Class 018 as bags, namely, handbags, rucksacks, school bags, traveling bags, traveling trunks, shoe bags for travel and garment bags for travel; valises, traveling trunks, pocket wallets, purses, card cases, namely, calling card cases, credit card cases and name card cases; umbrellas, parasols and walking sticks; and for goods identified in International Class 025 as clothing, namely, frocks, coats, suits, pants, skirts, shirts, blouses, tee-shirts, waistcoats, pullovers, vests, shorts, gloves, stockings, socks, belts, scarves; night clothing, namely, pajamas, dressing gowns, night gowns; lingerie articles, namely, underwear, underpants, slips, brassieres, breeches for wear; beach shoes; shoes except orthopedic shoes, headgear, namely, hats, caps, berets. ("Opposer's Mark"). Opposer's U.S. registration is valid and subsisting. A copy of a printout of the TSDR status for the registration is attached hereto as Exhibit A.



5. On May 30, 2014, Applicant filed an intent-to-use application to register Applicant's Mark, Application Serial No. 86296717, and the mark was published for opposition on May 5, 2015, for goods identified in International Class 025 as bras; camisoles; lingerie; loungewear; negligees; nightgowns; nightwear; panties; t-shirts; tank-tops; underwear, and for services recited in International Class 035 as on-line retail store services featuring clothing.

6. Opposer's priority date for Opposer's Mark is long before any date of use or

constructive date of use by Applicant of Applicant's Mark.

7. Opposer has developed widespread goodwill in Opposer's Mark. By reason of advertising, promotion, and other common activities in Opposer's industry, the consuming public recognizes Opposer's Mark and associates Opposer's Mark exclusively with Opposer and its goods.

8. Opposer's mark is inherently distinctive and is a strong mark and should be accorded the broad protection given to strong marks.

9. Use by Applicant of Applicant's Mark for which registration is sought in the application opposed herein is likely to cause confusion, mistake or deception as to the source of origin, sponsorship or approval of Applicant's goods in that purchasers or others are likely to believe that Applicant's goods are Opposer's, or are in some way legitimately connected with, licensed by, or approved by Opposer. Use by Applicant of Applicant's Mark for which registration is sought in the application opposed herein has lessened, and will continue to lessen, the capacity of Opposer's Mark to identify and distinguish goods made by Opposer.

10. Use by Applicant of Applicant's Mark for which registration is sought in the application opposed herein, is without Opposer's consent or permission.

11. Applicant's Mark is so similar to Opposer's Marks as to be likely to falsely suggest a connection between Applicant and Opposer.
