**CONSENT MOTION FOR AMENDMENT TO THE APPLICATION

Proposed amendment: “Providing an interactive website that allows organizations to enter, access, and generate career development information and reports for managers to assess their abilities and develop competencies for managing and retaining key employees” in International Class 42.

Applicant further requests that the opposition be suspended in order that the amendment requested herein be processed. This request for amendment to the identification of services and suspension is being made with the consent of the Opposer, further to a settlement agreement between the parties.

Moreover, Applicant submits that the amendment requested herein does not amount to a material alteration of the mark as filed or published, nor does it represent an expansion of the identification of services as published. Rather, the identification of Applicant's services has in fact been narrowed. Accordingly, as the amendment proposed herein will not require republication of the application, and as Opposer has consented to the amendment, Applicant requests the amendment to the identification of services be entered.

WHEREFORE, for the reasons set forth above, Applicant respectfully requests that the amendment requested herein be entered and that the opposition be suspended in the interim.
