

**PARTIAL ABANDONMENT OF THE APPLICATION
AND MOTION TO DISMISS**

Applicant, Svetlana Silcenkova, through her attorneys, hereby partially abandons U.S. Trademark Application Serial No. 79144310, by deleting therefrom the following goods:

“Beers; mineral and aerated waters and other non-alcoholic beverages, namely, soft drinks, sports drinks, non-alcoholic cocktails, energy drinks containing caffeine; fruit beverages and fruit juices; syrups and other preparations for making beverages, namely, fruit juices, powders and pastilles for effervescing beverages” in international class 32.
