**CONSENTED MOTION TO SUSPEND FOR ANOTHER 90 DAYS
DURING SETTLEMENT NEGOTIATIONS**

1 Applicant/Defendant, Landau Uniforms, Incorporated, by and through its attorney(s),
2 hereby moves, with the consent of Opposer/Plaintiff’s attorney, for a further 90-day suspension
3 of this action, and all deadlines, including the deadline for Applicant/Defendant to respond to
4 Opposer/Plaintiff’s Motion to Strike Applicant’s Affirmative Defenses, while the parties
5 continue to be engaged in settlement negotiations.

6 A draft settlement agreement document, along the lines that have been discussed, has
7 been sent to Opposer/Plaintiff by Applicant/Defendant, and Opposer/Plaintiff continues to
8 review that draft agreement. It is believed that said settlement agreement document, or a revised
9 version thereof, would resolve this matter amicably.

10 The parties are also in ongoing discussions regarding the settlement arrangements, and
11 this suspension / extension of time is needed while those discussions occur.

1 Applicant/Defendant is currently awaiting a response from Opposer/Plaintiff.

2 Because the parties in this action are attempting to settle this matter amicably, and are
3 still engaged in such negotiations, Applicant/Defendant's undersigned attorney, with the consent
4 on November 17, 2016, of Opposer/Plaintiff's attorney, Donna J. Bunton, Esq., jointly move the
5 T.T.A.B. for a further 90-day suspension of this Opposition while revisions to the settlement
6 agreement and terms of settlement are being negotiated, discussed, and finalized, together with a
7 90-day suspension of this opposition and all deadlines, including the deadline for
8 Applicant/Defendant to respond to Opposer/Plaintiff's Motion to Strike. The current deadline
9 for response to Opposer/Plaintiff's Motion to Strike is November 19, 2016. Other deadlines in
10 this matter are presently suspended pending a decision for Opposer/Plaintiff's Motion to Strike.
11 Extending this deadline by 90 days results in an extended deadline of:

12 Response to Motion to Strike: February 17, 2017

13 It is respectfully requested that this Motion be granted, and that all dates in this
14 opposition proceeding be further suspended for another 90 days so that the parties can complete
15 their negotiation of a settlement agreeable to both parties.
