Pursuant to the provisions of 37 C.F.R. §§ 2.171-2.176, G. Michael Roebuck, P.C., Respondent hereby submits this Motion to Amend Registration and Request for Certification to change the name of the owner from “Michael Roebuck, P.C.” to “G. Michael Roebuck, P.C. on Respondent’s trademark registration numbers 4055935 for Wild Rabbit Salad and 4999853 for Wild Rabbit.

I. INTRODUCTION

Respondent hereby submits this motion for Correction of a Mistake by Owner pursuant to 37 CFR §2.175 along with the fee required by 37 CFR 2.6, verified and signed motion signed in accordance 37 CFR §2.193(e)(6).

ARGUMENT

Respondent stated in the applications for registration numbers 4055935 for Wild Rabbit Salad and 4999853 for Wild Rabbit, that the applicant/owner’s corporate name was “Michael Roebuck, P.C.” when in fact the correct applicant/owner’s corporate name is “G. Michael Roebuck, P.C.” The prior corporation Michael Roebuck, P.C. (wholly owned by Respondent while it did exist) did not exist at the time of the application as the corporation had expired on February 11, 2000. (see attachment A) The present corporation, G. Michael Roebuck, P.C. was formed on January 3, 2006 (see attachment B) is still active (see Attachment C) was active in the State of Texas on the filing date of the Respondent’s

trademark applications for trademark registrations 4055935 and 4999853. Respondent verifies that it made this mistake in good faith without intent to deceive as to the ownership of the trademark applications.

II. CONCLUSION AND PRAYER

In light of the foregoing, Respondent respectfully request that Petitioner's Petition to Disqualify G. Michael Roebuck be denied.
