Applicant JustBrand Limited, by and through its attorneys and pursuant to 37 C.F.R. §2.120(a)(2), §2.127, and TBMP §403.04, respectfully files this Consented-to Motion For Extension of Time to File Answer to Notice of Opposition. In support of this motion, Applicant states as follows:

1. In accordance with Applicant’s Consented-To Motion For Extension of Time to Answer, filed on or about June 12, 2017 with the Trademark Trial and Appeal Board (the “Board”) and subsequently granted on July 5, 2017, the period for Applicant’s time to file its Answer was reset so as to close on July 15, 2017.

2. Since the Board’s issuance of its order on July 5, 2017, the parties have continued apace with settlement discussions.

3. Through regular e-mail communication, Applicant and Opposer have narrowed the range of disputed issues and are now negotiating the terms of a written settlement proposal that would resolve the above-captioned dispute as well a potential related dispute.

4. Although the parties appear to be nearing agreement, additional time is required resolve the remaining issues.

5. Based on the foregoing, the parties request that Applicant's time to answer be extended for 30 days, or until August 14, 2017, and that all subsequent dates be reset accordingly.

6. The Opposer, Alpha Industries, Inc., through its attorney, likewise agrees to this extension and has expressly consented to this motion.

For the foregoing reasons, Applicant, JustBrand Limited, acting with the consent of Opposer Alpha Industries, Inc., respectfully requests that the Trademark Trial and Appeal Board grant this Consented-to Motion For Extension of the time to Answer the Notice of Opposition up to and including August 14, 2017.
