NOTICE OF OPPOSITION

Opposer Compassion International, Inc., a non-profit corporation of Illinois, having a principal place of business at 12290 Voyager Parkway, Colorado Springs, Colorado 80921, believes that it will be damaged by the registration of the mark WOMEN OF COMPASSION shown in U.S. Trademark Application Serial Nos. 86/817,585 for "Association services, namely, promoting the interests of children's homes and orphanages; charitable services, namely, organizing women's groups to undertake projects which benefit orphans and abused, neglected, abandoned, disadvantaged, and displaced children; charitable services, namely, promoting public awareness of orphans and abused, neglected, abandoned, disadvantaged, and displaced children through newsletters and other means," in International Class 35 and "Charitable fundraising services; charitable fundraising to support orphans and abused, neglected, abandoned, disadvantaged, and displaced children," in International Class 36 (the "Application") and hereby opposes it.

As grounds for its opposition, Compassion International, Inc. alleges that, upon actual knowledge with respect to itself and its own actions, and upon information and belief as to other matters:

- 1. Compassion International, Inc. is a Christian child development organization assisting over 1.2 million children in 26 countries, including the United States, in a variety of charitable, educational, medical, food and spiritual endeavors. Compassion International, Inc. has been providing these services since approximately 1966.
- 2. Compassion International, Inc. owns the following registered trademarks and service marks for COMPASSION and COMPASSION-formative marks in connection with its various charitable services:
 - a. COMPASSION, Registration No. 2,988,651, for "charitable fund raising for child advocacy, child development, and youth assistance programs" in Class 36, "charitable services, namely, providing food and temporary shelter to needy children" in Class 43, "charitable services, namely, providing medical care to needy children" in Class 44 and "charitable services, namely, providing Christian spiritual counseling for needy children" in Class 45, in use since December 31, 1966.
 - b. COMPASSION, Registration No. 1,552,859, for "magazines dealing with Christian child development" in Class 16, in use since April 1959.
 - c. Compassion, Registration No. 3,806,533, for "charitable services, namely, providing medical care to needy children" in Class 44

and "charitable services, namely, providing Christian spiritual counseling for needy children" in Class 45, in use since March 19, 2001.



d. , Registration No. 2,669,765, for

"charitable fund raising for child advocacy, child development, and youth assistance programs" in Class 36 and "charitable services, namely, providing food, shelter, medical care, education assistance, and Christian spiritual counseling for children" in Class 42, in use since January 30, 2001.

- e. COMPASSION AT WORK, Registration No. 3,390,622, for "publications, namely, newsletters addressing child development and child advocacy" in Class 16, in use since October 18, 1999.
- f. SPEAK UP WITH COMPASSION, Registration No. 2,826,007, for "radio entertainment services, namely, radio programs featuring issues dealing with child advocacy and child development; charitable services, namely, providing training in the field of child advocacy and child development" in Class 41, in use since March 3, 2003.
- g. COMPASSION INTERNATIONAL, Registration No. 4,579,905, for "charitable fund raising for child advocacy, child development, and youth assistance programs" in Class 36, "charitable services, namely, providing food and temporary shelter to needy children" in Class 43, "charitable services, namely, providing medical care to needy children" in Class 44,

- and "charitable services, namely, providing Christian spiritual counseling for needy children" in Class 45, in use since 1966.
- 3. The foregoing registrations are valid and subsisting and constitute prima facie evidence of the validity of the marks and registrations, of Compassion International, Inc.'s ownership of and exclusive right to use the marks in commerce, and provide constructive notice of Compassion International, Inc.'s rights.
- 4. Since approximately 1966, Compassion International, Inc. has used the marks COMPASSION and COMPASSION INTERNATIONAL in commerce in connection with its various charitable, evangelical, and ministerial services. Since approximately 2010, Compassion International, Inc. has also used the mark WOMEN OF COMPASSION to denote its community of women workers and volunteers from around the world. Compassion International, Inc. owns common law rights in the COMPASSION, COMPASSION INTERNATIONAL, and WOMEN OF COMPASSION marks for such services. The common law COMPASSION, COMPASSION INTERNATIONAL, and WOMEN OF COMPASSION marks, together with the registered marks listed in Paragraphs 2(a) (g), are hereinafter collectively referred to the "Compassion Marks."
- 5. Compassion International, Inc. has expended considerable time, money, and effort marketing and advertising its charitable services under the Compassion Marks. As a result of these expenditures and Compassion International Inc.'s many years of service to millions of impoverished people around the world, the Compassion Marks have become famous.

COUNT I Likelihood of Confusion 15 U.S.C. § 1052(d)

- 6. Compassion International, Inc. realleges and incorporates by reference the preceding allegations of its Notice of Opposition.
- 7. Since well prior to the filing date of the Application, Applicant's first use of the WOMEN OF COMPASSION mark, or any priority date upon which Applicant may rely, Compassion International, Inc. has used one or more of the Compassion Marks.
- 8. Applicant's WOMEN OF COMPASSION trademark so resembles Compassion International, Inc.'s prior used and registered Compassion Marks as to be likely, when used in connection with the goods set forth in the Application, to cause confusion, or to cause mistake, or to deceive under Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).

COUNT II Likelihood of Dilution 15 U.S.C. § 1125(c)

- 9. Compassion International, Inc. realleges and incorporates by reference the preceding allegations of its Notice of Opposition.
- 10. The Compassion Marks are famous and well known and became famous under 15U.S.C. § 1125(c) well prior to the filing date of the Application, Applicant's first use of theWOMEN OF COMPASSION mark, or any priority date upon which Applicant could rely.
- 11. Applicant's Women of Compassion trademark so resembles Compassion International, Inc.'s prior used and registered Compassion Marks as to dilute or to be likely to cause dilution of the distinctive quality of the Compassion Marks by blurring under section 43(c) of the Lanham Act, 15 U.S.C. § 1125(c).

WHEREFORE, Compassion International, Inc. believes that it will be damaged by registration of the mark shown in the Application, Compassion International, Inc. respectfully requests that the opposition be sustained, and that registration to Applicant be refused.
