NOTICE OF OPPOSITION

Stefano Ricci SPA, a Société par Actions duly organized and existing under the laws of Italy, with a principal place of business at Via Faentina 171, I-50010 FIESOLE (FI) Italy, believes that it would be damaged by the registration of the mark shown in the above-identified application, and hereby opposes that mark, pursuant to 15 USC 1063.

As grounds for opposition, it is alleged that:

(1) Stefano Ricci SPA, since a time prior to the filing of the applicant's use based application, has been using its trademark STEFANO RICCI in connection with the sale of a variety of goods including textile fabrics for use in the manufacture of household furnishings and clothing, household goods of textiles, clothing and related items. Said use has been valid and continuous since its first use and has not been abandoned.

(2) Stefano Ricci SPA is the owner of U.S. trademark registrations for various goods including textiles, namely, textile fabrics for use in the manufacture of household furnishings and clothing; towels of textile; table linen of textile; bed blankets; quilts; down coverlets, namely, eiderdowns; tablecloths, not of paper; bed sheets and bath sheets and related goods and clothing and related goods all with filing dates previous to the date of filing of the applicant's use based application.

(3) Stefano Ricci SPA is the owner of the following valid and subsisting U.S. trademark registrations whose TSDR printouts are attached:

STEFANO RICCI - Registration No. 2545498, filed September 13, 1996, registered: March 12, 2002; and

STEFANO RICCI - Registration No. 4824614, filed August 5, 2013, priority date February 20, 2013. registered: October 6, 2015.

(4) Stefano Ricci SPA's registrations are valid and subsisting and are prima facie proof of ownership of the mark, pursuant to 15 USC 1057(b), and of the exclusive right to use the registered marks in commerce on the goods specified in said registrations.

(5) Stefano Ricci's U.S. Registration No. 2545498 is incontestable.

(6) Stefano Ricci SPA has used its mark in commerce and has acquired valuable goodwill and recognition for its marks. Resulting from this use, the public has come to associate "STEFANO RICCI" with Opposer and Opposer's goods.

(7) Textile goods, including the goods of the Applicant's trademark, are a natural expansion area to clothing goods.

(8) On information and belief, Applicant's mark has not yet been used in commerce.

(9) On information and belief, both Applicant's mark and Stefano Ricci SPA's marks will be applied to identical or highly related goods and are likely to be sold through the same or similar channels of distribution.

(10) Applicant's mark so resembles Stefano Ricci SPA's registrations and trademarks in sight, sound and commercial impression, as used in the United States and not abandoned, that when applied to the same or similar goods, would be likely to cause
