The referenced application has been reviewed by the assigned trademark examining attorney. Applicant must respond timely and completely to the issue(s) below. 15 U.S.C. §1062(b); 37 C.F.R. §§2.62(a), 2.65(a); TMEP §§711, 718.03.

**SEARCH OF OFFICE'S DATABASE OF MARKS**

The trademark examining attorney has searched the Office's database of registered and pending marks and has found no conflicting marks that would bar registration under Trademark Act Section 2(d). TMEP §704.02; *see* 15 U.S.C. §1052(d).

**Amendment of Identification**

Particular wording in the proposed amendment to the identification is not acceptable because it exceeds the scope of the identification in the application. *See* 37 C.F.R. §2.71(a); TMEP §§1402.06 *et seq.*, 1402.07. The original identification in the application, and any previously accepted amendments, remain operative for purposes of future amendment. *See* 37 C.F.R. §2.71(a); TMEP §1402.07(d).

An acceptable identification of goods and/or services is required in an application. *See* 37 C.F.R. §§2.32(a)(6), 2.71(a); TMEP §§805, 1402.01. An applicant may only amend an identification to clarify or limit the goods and/or services, but not to add to or broaden the scope of the goods and/or services. 37 C.F.R. §2.71(a); *see* TMEP §§1402.06 *et seq.*, 1402.07. Scope is generally determined by the ordinary meaning of the wording in the identification. TMEP §1402.07(a).

The application originally identified the goods and/or services as follows: "Incubation services, namely, providing work space containing business equipment to freelancers, start-ups, existing businesses and non-profits."

However, the proposed amendment identifies the goods and/or services as follows: "Incubation services, namely, providing work space

containing business equipment to freelancers, start-ups, existing businesses and non-profits,” and “**Rental of office space ; Incubation services, namely, rental of office space to freelancers, start-ups, existing businesses and non-profits.**”

This portion of the proposed amendment is beyond the scope of the original identification because the services, “Incubation services, namely, providing work space containing business equipment to freelancers, start-ups, existing businesses and non-profits,” was not a part of the original services and therefore exceeds the scope of the original identification of goods.

Thus, the identification, incorporating this amendment, is not acceptable. *See* 37 C.F.R. §§2.32(a)(6), 2.71(a); TMEP §§805, 1402.01.

#### CHANGE OF OWNERSHIP IN AMENDMENT

Applicant has requested that the owner name be amended; however, applicant has not provided a reason for this request, or provided or recorded ownership transfer documentation. The name of the original applicant is Marilyn Yu; applicant seeks to amend this to Shared LLC. The request to change the owner name raises a question regarding whether the proper party filed the original application. Therefore, applicant must clarify whether the proper party filed the original application. In addition, the request to amend the owner name is denied until clear chain of title to the new party has been established.

An application is void if it was filed in the name of a party who did not own, or was not entitled to use, the applied-for mark on the application filing date. 37 C.F.R. §2.71(d); *Huang v. Tzu Wei Chen Food Co.*, 849 F.2d 1458, 1459-60, 7 USPQ2d 1335, 1335-36 (Fed. Cir. 1988); TMEP §§803.06, 1201.02(b); *see* 15 U.S.C. §1051(a)(1). A void application cannot be cured by amendment or assignment. TMEP §§803.06, 1201.02(b); *see* 37 C.F.R. §2.71(d). In these cases, the true owner must file a new application. TMEP §803.06.

If the application was filed by the owner and the original applicant has since changed its name or transferred ownership of the mark to another entity, the new owner must file documentation to establish its ownership of the application as follows:

- (1) The new owner must (a) record an assignment, name change, or other documentation affecting title with the USPTO’s Assignment Recordation Branch showing a clear chain of title to the mark in the new owner; and (b) promptly notify the trademark examining attorney that the documentation has been recorded.
- (2) The new owner must file either (a) a written statement, verified with an affidavit or signed declaration under 37 C.F.R. §2.20, explaining in detail the chain of title to the new owner; or (b) documentation showing transfer of title to the new owner. However, the registration will not issue in the name of the new owner without recording chain of title documentation with the USPTO and notifying the trademark examining attorney, as specified in (1) above.

TMEP §502.01; *see* 15 U.S.C. §1060; 37 C.F.R. §§2.193(e)(1), 3.73(b)(1); TMEP §502.02(a).

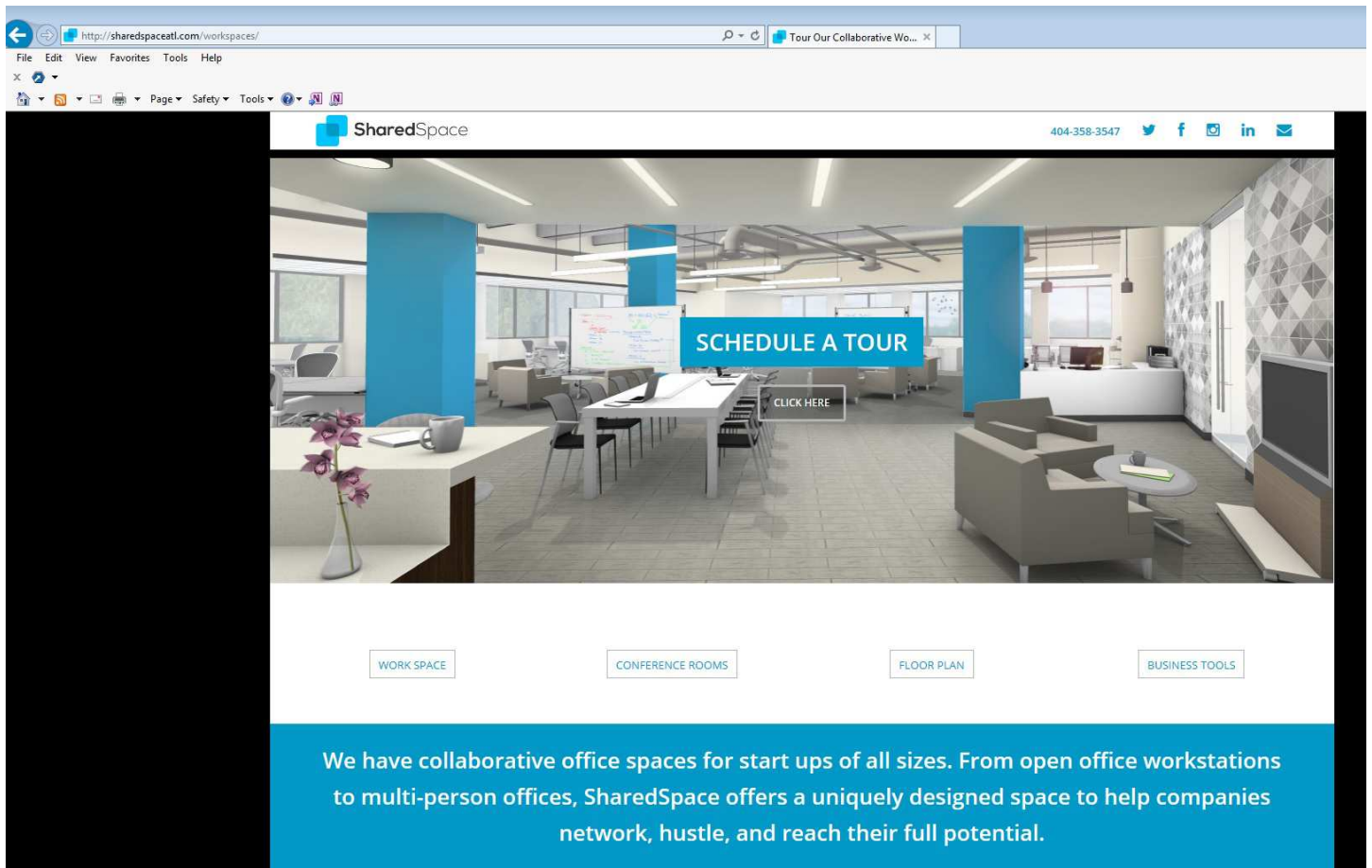

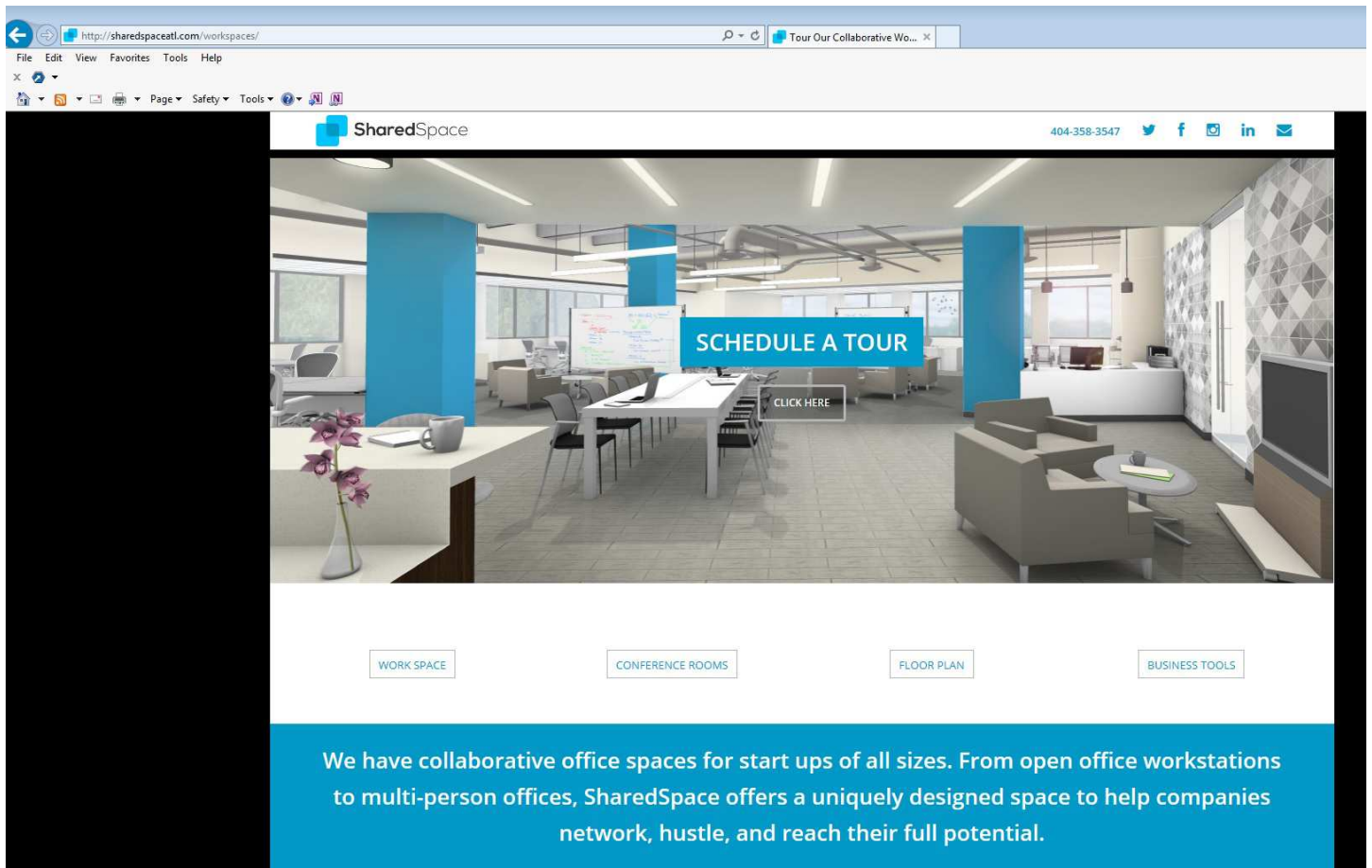

Inviro Med. Devices, Ltd.*, 695 F.3d 1247, 1251, 103 USPQ2d 1753, 1755 (Fed. Cir. 2012) (quoting *In re Oppedahl & Larson LLP*, 373 F.3d 1171, 1173, 71 USPQ2d 1370, 1371 (Fed. Cir. 2004)); TMEP §§1213, 1213.03(a).

The attached evidence shows the word "share" means "to have or use something with others" and "space" is defined as "the amount of an area, room, surface, etc., that is empty of available for use." (*See Merriam-Webster's online dictionary, 11<sup>th</sup> edition, attached*). Further, the attached websites show that the wording "shared space" is commonly used in connection with similar services to mean co-use of office space. (*See attached from forbes.com, pivotdesk.com*). Therefore, the wording merely describes a function, feature, purpose, and use of applicant's services.

An applicant may not claim exclusive rights to terms that others may need to use to describe their goods and/or services in the marketplace. *See Dena Corp. v. Belvedere Int'l, Inc.*, 950 F.2d 1555, 1560, 21 USPQ2d 1047, 1051 (Fed. Cir. 1991); *In re Aug. Storck KG*, 218 USPQ 823, 825 (TTAB 1983). A disclaimer of unregistrable matter does not affect the appearance of the mark; that is, a disclaimer does not physically remove the disclaimed matter from the mark. *See Schwarzkopf v. John H. Breck, Inc.*, 340 F.2d 978, 978, 144 USPQ 433, 433 (C.C.P.A. 1965); TMEP §1213.

## Thinking Outside the Box When it Comes to Office Space

ERHET POST, the first way to creatively deal with the need for office space is to examine staff. Minimizing the workforce for my companies through independent contractor agreements, internships, and sweat-equity arrangements reduced the need for lots of office space.

Another great technique is finding co-working space, which are flexible and allow you to rent by the day, month, or year. With the increase of digitally-based companies, co-working environments can be great solution for start-ups that don't have a big footprint and want to interact with other like-minded people. The key to co-working spaces is that they foster collaboration. *FastCompany* recently published a great [article](#) on the benefits of these types of arrangements.

Shared office space also is yet another great alternative to leasing that encourages collaboration and provides opportunities to share your ideas with others. There are dozens of way to take advantage of sharing office space with other companies. For example, as they've cut back during tough economic times many companies have more office space than they need. They are losing money on that excess space and are often willing to sublet the space. That is why companies like [PivotDesk](#) got started. PivotDesk was designed to match small businesses with larger companies that have more space

match small businesses with larger companies that have more space than they actually need. You essentially get to rent a desk or a cubicle for a flat fee. The nice thing about the arrangement is that it can be done with the click of just a few buttons.

Actual shared office space companies are another approach. Companies like Regus have a global footprint that allows small companies to lease individual offices. This cuts down on the time needed to find space, set up internet, hook up phone lines, and maintain these services because everything is included in an office package. You have access to a receptionist, conference rooms, kitchens, and everything you need to just set up your computer and get started.

Another topic I covered in a previous post also can be used to find office space: [bartering](#). The art of bartering is making a comeback when it comes to shared office space. Platforms like Craigslist give start-ups the opportunity to reach out to companies who have space and are willing to allow people to use it for a service in exchange. I ran across a great Craigslist posting recently in Philadelphia where someone who had just started a new counseling practice was willing to offer administrative services in exchange for free space. Depending on the type of business you have, you could also ask a client or vendor if they have excess space. Barter for use of a boat, timeshare or other asset / access you may have. Bartering is fun because it is only limited by your imagination.

Even though there are lots of options, sometimes you have to think really outside of the box. When I launched GetLoaded.com, I had a tough time finding space that didn't require at least a three year

though office building space that usually require at least a three year lease. Also at the time, the cost per square foot for commercial space was very inflated. So instead of renting office space, I rented a house. It was ideal because I could rent the house on an annual basis at a much lower cost per square foot and the layout of the house was ideal for desks and a conference room table. This setup got even better when one of the programmers had to move from North Carolina. Instead of him renting an apartment I offered him the upstairs in exchange for a smaller salary. He took it and the arrangement worked out perfectly.

There is no one solution for office space needs and I encourage you to be creative when thinking about office space. Saddling a start-up business with a huge liability like a 3-5 year lease can be tough when resources are limited. Especially when there are so many alternative solutions available.

San Francisco is full of creative people, however because of a shortage of space, creativity and collaboration can often be a struggle. Founder, Marilyn Vu ([artist](#) and [clothing designer](#)), is a creative person who likes collaborating with others. She believes that a sustainable space for creative people can exist in San Francisco.

In 2010 while brainstorming with Frank Flores, a good friend and fellow alum from Berkeley's City and Regional Planning program, the idea for SHARED was hatched. In 2011 she met [Bill Lora](#), an architect who had recently relocated from the East Coast. Bill, a long-time member of Third Ward in Brooklyn, was excited to build a space in his new home, San Francisco, for creative people.

Marilyn and Bill searched for an appropriate building with Marilyn's friend and commercial real estate broker [Jay Shaffer](#). In the summer of 2012 they finally found 739 Bryant Street: a solid building, in a good location, and at a price Marilyn could afford. With the help of the Small Business Administration and the

[Bank of San Francisco](#), Marilyn was able to purchase 739 Bryant Street in September 2012.
