NOTICE OF OPPOSITION


Opposer Integrity Mutual Insurance Company, a Wisconsin corporation located at 2121 East Capitol Drive in Appleton, Wisconsin, believes it will be damaged should the above-referenced application (the “Application”) register and opposes it as set forth below:

1. Opposer is the owner of U.S. trademark registrations for the mark INTEGRITY (Reg. No. 3,134,629) and INTEGRITYONE (Reg. No. 4,246,457), which cover *insurance underwriting in the field of property, casualty, home, auto, motorcycles and business and insurance services, namely, underwriting home and auto insurance*, respectively. Registration Number 3,134,629 was filed on June 19, 2003 and registered August 29, 2006, and Registration Number 4,246,457 was filed on August 18, 2010 and was registered November 20, 2012. TSDR printouts of these registrations showing current status and title are attached as **Ex. A**.

2. On information and belief, Opposer has continuously used its house mark INTEGRITY in connection with the provision of insurance services in United States commerce since at least January 7, 1992. Further, on information and belief, Opposer has continuously

used the related mark INTEGRITYONE in connection with the provision of insurance services in United States commerce since at least April 12, 2012.

3. In addition to registrations for the marks INTEGRITY and INTEGRITYONE, Opposer also owns the following registrations which contain the mark INTEGRITY (together with INTEGRITY and INTEGRITYONE, “Opposer’s INTEGRITY Marks”):

4. To the best of Opposer’s knowledge, Integrity One Services, Inc. (“Applicant”) is a Florida corporation located at 3508 N. Armenia Avenue, Tampa, Florida 33607.

5. On June 4, 2015, Applicant filed use-based Application Serial Number 86/651,705 to register the mark INTEGRITY ONE (“Applicant’s Mark”) for the following insurance-related goods and/or services:

- *IC 9 - Computer software for insurance processing, namely, software for processing non-standard automobile insurance covering and for providing transactions, namely, policy quotes, policy binding, policy renewal, bodily injury liability, property damage liability, personal injury protection, medical payments, uninsured motorists, comprehensive loss, collision loss, loss of use, custom and additional equipment, accidental death, policy endorsement, policy payment transaction, claims acceptance, claims management, claims reporting, business analytics and reporting, and financial reporting*
- *IC 42 - Providing temporary use of on-line non-downloadable software for insurance processing, namely, software for processing non-standard automobile insurance covering and for providing transactions, namely, policy quotes, policy binding, policy renewal, bodily injury liability, property damage liability, personal injury protection, medical payments, uninsured motorists, comprehensive loss, collision loss, loss of use, custom and additional equipment, accidental death, policy endorsement, policy payment transaction, claims acceptance, claims management, claims reporting, business analytics and reporting, and financial reporting*

A TSDR printout of this registration showing current status and title is attached as **Ex. C**.

6. Application Serial Number 86/651,705 claims a first use date for Applicant's Mark of April 30, 2014, well after the filing and first use dates of Opposer's registrations for the marks INTEGRITY and INTEGRITYONE and, in fact, after the filing dates of *each* of Opposer's registrations that contain the mark INTEGRITY.

7. On June 4, 2015, Applicant also applied to register the mark INTEGRITY ONE "OUR PRIORITY – YOUR SUCCESS" & Design (App. Ser. No. 86/651,715). In that application, Applicant failed to respond to an office action refusal issued on September 16, 2015 based on a likelihood of confusion with Opposer's mark INTEGRITYONE (Reg. No. 4,246,457) (**Ex. A**). Further, prior to abandonment, the Office of the Deputy Commissioner forwarded to the Examining Attorney prosecuting that application a "Letter of Protest Memorandum" indicating that Opposer's other INTEGRITY marks were "relevant and may support a reasonable ground for refusal." A TSDR printout of this abandoned application showing current status and title is attached as **Ex. D**.

LIKELIHOOD OF CONFUSION

8. Registrations for Opposer's INTEGRITY Marks are *prima facie* evidence of the validity of Opposer's INTEGRITY Marks and Opposer's ownership and exclusive right to use that mark in commerce, and provide constructive notice of Opposer's ownership of the marks, all as provided under Sections 7(b) and 22 of the Federal Trademark Act of 1946, as amended.

9. Applicant's Mark is confusingly similar to Opposer's INTEGRITY Marks because Applicant's Mark is identical to Opposer's mark INTEGRITYONE and highly similar to the remainder of Opposer's INTEGRITY Marks. Further, the services and/or goods identified in Application Serial Number 86/651,705 are nearly identical or at least very closely related to those sold under Opposer's INTEGRITY Marks, as both Opposer's and Applicant's goods and/or services involve the provision of insurance.

10. Because of the similarity between Opposer's INTEGRITY Marks and Applicant's Mark, and the near identity and close relatedness between Applicant's services and goods and Opposer's services, Applicant's Mark so resembles Opposer's INTEGRITY Marks as to be likely to cause confusion or mistake, or to deceive the public. As a result, use of Applicant's Mark will cause the public to believe, incorrectly, that Applicant's goods and/or services emanate from, are authorized or endorsed by, or are otherwise connected with Opposer. Therefore a registration should not issue pursuant to Section 2(d) of the Lanham Act, 15 U.S.C. §1052(d).

11. Opposer has not consented to Applicant's use of or application to register Applicant's Mark.

For the foregoing reasons, this opposition should be sustained and Application Serial No. 86/651,705 should be refused. Please direct all correspondence to counsel for Opposer at the
