Applicant WINEFORCES and Opposer SEASIDE COMMUNITY DEVELOPMENT CORP., by and through their respective attorneys, hereby move the Board to continue Applicant's deadline to respond to the Motion to Dismiss that Opposer filed on January 19, 2016.

The parties remain actively engaged in settlement discussions, and have agreed to continue the upcoming briefing deadlines for Opposer's pending Motion to Dismiss. Applicant's deadline to respond to the Motion to Dismiss is presently April 10, 2017.

On March 24, 2017, counsel for Applicant and counsel for Opposer each agreed to an extension of thirty (30) days for Applicant's response to the pending Motion to Dismiss.

To allow adequate time for ongoing settlement discussions to occur, the parties respectfully move the Board to continue Applicant's deadline to respond to the Motion to Dismiss by thirty (30) days, from April 10, 2017 to May 10, 2017.

The deadline for any Reply brief in response to Applicant's opposition will be calculated based on that new deadline for filing the opposition to the motion.
