CONSENTED MOTION TO AMEND TRADEMARK APPLICATION

Applicant, by and through its counsel, hereby requests pursuant to 37 C.F.R. § 2.133(a) that the Trademark Trial and Appeal Board (“Board”) amend Application Serial No. 86/766,927 as described herein. Specifically, Applicant requests the recitation of goods be amended to read: “Distilled spirits, namely, rum and flavored rum, to exclude whiskey, bourbon, and flavored whiskey”.
