NOTICE OF OPPOSITION

Opposer, International Code Council, Inc. (“Opposer” or “ICC”) believes that it will be damaged by the issuance of a registration for the mark ICC ACADEMY, as applied for in Application Serial No. 79/172,418 (the “Application”), filed by Chambre de Commerce Internationale (“Applicant”), and hereby opposes the same.




As grounds for opposition, Opposer alleges the following, upon actual knowledge with respect to itself and its own acts, and upon information and belief as to other matters:



Opposer and its ICC Marks

1. ICC is a corporation organized and existing under the laws of California, with its principal place of business at 3060 Saturn Street, Suite 100, Brea, CA 92821.

2. Since at least as early as 1994, ICC has engaged in the development, provision, distribution, sale, advertising and promotion in the United States and abroad of building and construction codes and standards, including the testing, analyzing and evaluation of the goods and services of others for the purpose of certification.

3. As shown below, ICC owns numerous federal registrations for its marks comprised of or containing the term “ICC” and a globe design, as well as registration of its mark ICC (collectively “Opposer’s ICC Marks”). In accord with 37 C.F.R. § 2.122(d), copies of the registration certificates for each of Opposer’s ICC Marks are attached as Exhibit A hereto.

7. On February 23, 2016, the Application was published for opposition in the Official Gazette, and Opposer subsequently filed timely extensions of time to oppose on March 22, 2016, and June 21, 2015 (with Applicant's consent).

Likelihood of Confusion, 15 U.S.C. § 1052(d)

8. ICC repeats and realleges each and every allegation set forth above.

9. ICC has priority with respect to Opposer's Goods and Services based on its valid and subsisting registrations for Opposer's ICC Marks set forth in Paragraph 3 above. ICC also has priority based on its prior common law use of Opposer's ICC Marks in connection with Opposer's Goods and Services.

10. Applicant's Mark includes the term "ICC" together with only the descriptive word "ACADEMY" (disclaimed by the Applicant), which is an element of Opposer's ICC Marks and the entirety of Opposer's ICC mark, Reg. No. 4,718,932.

11. Moreover, Applicant's Goods and Services are identified so broadly in the application that certain of such goods and services are the same as and/or overlap with and/or are related to Opposer's Goods and Services.

12. Accordingly, Applicant's Mark so resembles Opposer's ICC Marks in appearance and sound, as to be likely, when used and registered in connection with those

of Applicant's Goods and Services that are the same as and/or overlap with and/or are related to Opposer's Goods and Services, to cause confusion, or to cause mistake, or to deceive in violation of Section 2(d), 15 U.S.C. § 1052(d); and will thereby injure and damage Opposer and the goodwill and reputation symbolized by Opposer's ICC Marks.

WHEREFORE, ICC respectfully requests that the opposition be sustained, and that registration of the mark in Application Serial No. 79160195 be refused.
