Report to Establish Good Cause

I. Recitation of Discovery Taken to Date

Attorneys for Opposer and Applicant have exchanged contact information, the identities of individuals who possess relevant factual information regarding use of the mark at issue and marks related thereto, information regarding the nature and extent of use of the mark at issue and marks related thereto, and purported specimens of use for these marks.

II. Statement of Resolved and Unresolved Issues

The parties have not yet fully resolved issues relating to first use dates of the mark at issue and marks related thereto, and the nature and extent of the purported uses.

III. Timetable for Resolution

The Parties are hopeful for a full resolution of this matter prior to the next proposed extended trial deadline (January 14, 2020) set forth in the proposed trial calendar above.
