

NOTICE OF OPPOSITION

The Burton Corporation, a Vermont corporation with an address at 80 Industrial Parkway, Burlington, Vermont 05401 (hereinafter, “Opposer”), believes that it will be damaged by the registration of the WP WHITEPEARL and Design mark, which is set forth in Application Serial No. 86/807,337, owned by White Gold LLC, a California limited liability company having an address at Suite 200, 2945 Townsgate Road, Westlake Village, California 91361 (hereinafter, “Applicant”), and hereby opposes registration of the same.

As grounds for opposition, Opposer alleges as follows:

1. Opposer uses the mark AN and Design depicted here –



– in the U.S. in connection with goggles, clothing and helmets, with use dating from before the earliest date Applicant can possibly claim as its date of first use (collectively, the “AN Mark”).

2. Opposer is the owner of U.S. Registration No. 2,733,078 for the mark AN and Design for “Sport goggles for use in winter sports, namely, snowboarding,” in International Class 28 (the “AN Registration”). A true and correct copy of the Certificate of Registration, which issued on July 1, 2003 and has attained incontestable status, is attached as **Exhibit A**.

3. On November 2, 2015, Applicant filed an application, Serial No. 86/807,337, to register the mark WP WHITEPEARL and Design depicted here –



– based on Applicant’s alleged intent to use the mark in commerce in connection with a wide variety of clothing items in Class 25, including “hats,” “neck warmers,” “thermal underwear,” “ski masks,” “ski wear,” and “skiing shoes,” as well as “ballet shoes,” “baby layettes,” “swimwear,” “football boots,” “horse-riding pants,” “hosiery,” “maternity clothing,” “shoes for the protection of airline passengers’ feet during airport security screening,” and “wedding dresses” (the “WP Application”). A true and correct printout from the website of the USPTO setting forth the details of the WP Application is attached as **Exhibit B**.

4. The application filing date of the AN Registration precedes the filing date of the WP Application.

5. On information and belief, Opposer’s AN Mark has been in continuous use in commerce since before any use by Applicant of the mark set forth in the WP Application.

COUNT I Likelihood of Confusion

6. In view of the fact that the mark in the WP Application is highly similar to Opposer’s AN Mark, and that the goods set forth in the WP Application are highly related to the

goods offered under Opposer's AN Mark, the mark in the WP Application is likely to cause confusion, or to cause mistake, or to deceive within the meaning of Section 2(d) of the Trademark Act. Opposer will thereby be injured by the registration of Application Serial No. 86/807,337.

COUNT II
Lack of Bona Fide Intent To Use


7. On information and belief, Applicant did not have a *bona fide* intent to use the mark in the WP Application in U.S. commerce on or in connection with some or all of the goods identified in the WP Application as of the filing date of November 2, 2015.

WHEREFORE, Opposer asks that this Notice of Opposition be sustained and judgment be entered in favor of Opposer.

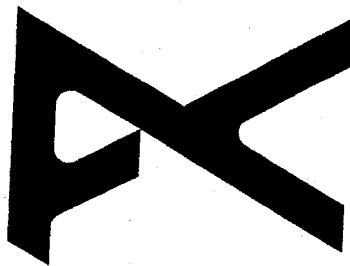

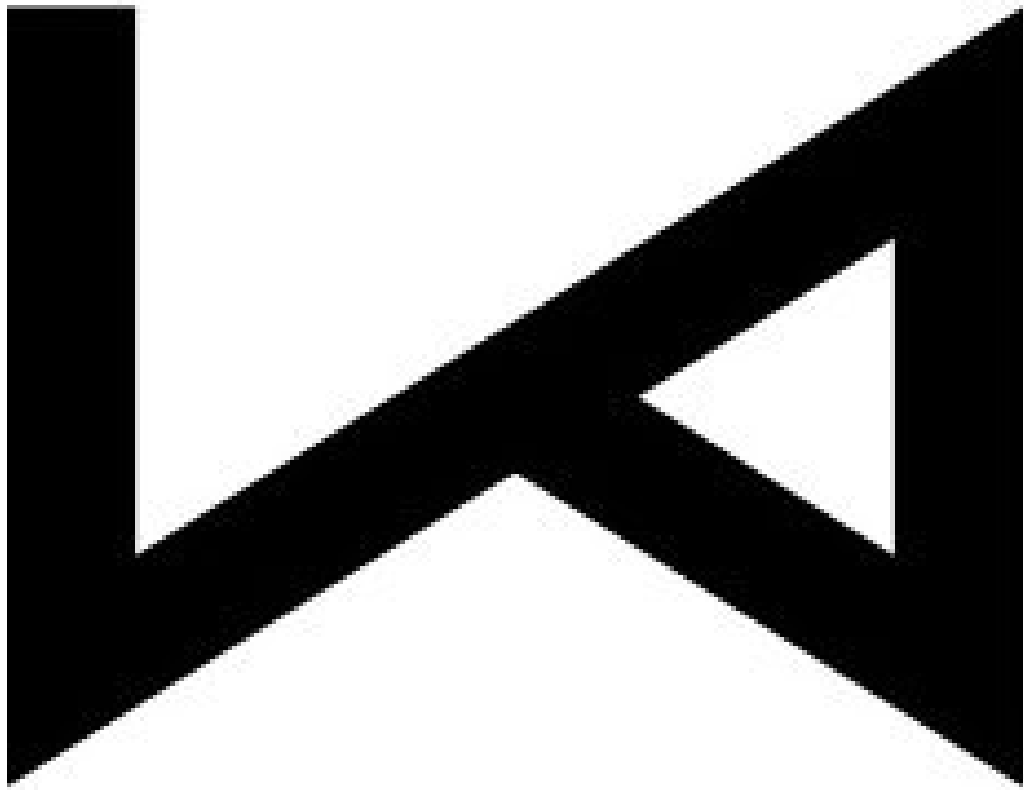
