Supplemental Report in support of Defendant's Motion to Suspend with Consent

Further to the Board's Order of September 13, 2018, Applicant is supplementing information in support of the consented motion to suspend filed on September 6, 2018. The parties U.S. counsels are working with respective UK counsels and information of the recent status of communications was obtained from Applicant's UK counsel today. We inform the Board of the latest status of ongoing settlement negotiations:

18 June 2018

Counterproposal from Opposer's representative by email.

17 August 2018

Conference call between representatives regarding proposal.

30 August 2018

Follow-up email from Opposer's representative after conference call.

4 September 2018

Conference call between representatives. Follow up email from Applicant's representative. Further telephone discussion between representatives.

1 October 2018

Email from Opposer's representative seeking clarification of minor points in settlement proposal.

4 October 2018

Conference call between representatives. Settlement appeared close to both parties.

The Applicant is currently seeking to address minor remaining queries that the Opposer has in

relation to the final settlement agreement. The one outstanding point is coverage of goods/services.

The corresponding UK proceedings are currently stayed until 6 December 2018, and it is the intention of both sides to have a global settlement in place before that date. Suspension of the U.S. proceedings will obviate the need for commencement of discovery and costs associated therewith.

It is respectfully requested that the Motion to suspend these proceedings be granted.

Captain William G. MacDonald has secured the express consent of all other parties to this proceeding for this suspension and resetting of dates as generated in the motion as filed on September 6, 2018 or as the Board deem appropriate.

Captain William G. MacDonald has provided an email address herewith for itself and for the opposing party so that any order on this motion may be issued electronically by the Board.
