To date, the parties have made progress regarding disputes concerning Applicant's mark in various jurisdictions. They seek the additional time to continue to pursue a resolution of this matter. The parties continue to believe that settlement is possible and wish to pursue this course of action in hopes of minimizing additional costs and avoiding potential future disputes.
