NOTICE OF OPPOSITION

CenturyLink Inc., a Louisiana corporation, and its wholly owned subsidiary CenturyLink Intellectual Property LLC, f/k/a Embarq Holdings Company, LLC, a Delaware limited liability company with a business address of 100 CenturyLink Drive, Monroe, Louisiana 71203, (hereinafter “Opposers”), believe that they will be damaged by the registration of the mark shown in the above-identified application, and, having been granted extension of time until November 20, 2016, hereby oppose the same.

licensed by Opposers, or that there is some relationship between Applicant and Opposers.

30. Opposers are likely to be damaged by the registration sought by Applicant because such registration will support and assist Applicant in the confusing and misleading use of the mark Applicant seeks to have registered, and will give color of exclusive statutory rights to Applicant in violation and derogation of the prior and superior rights of Opposers.

31. For the reasons set forth above, any use of the PACIFIC CENTURY CYBERWORKS mark by Applicant is likely to cause confusion, cause mistake or deceive the public, and cause the public to believe that the goods and services sold under the PACIFIC CENTURY CYBERWORKS mark emanate from or are otherwise sponsored by or endorsed by Opposers, in violation of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).

WHEREFORE, Opposers believe they will be damaged by registration of application Serial No. 86490786 and respectfully pray that the registration sought by Applicant be refused, and that this Notice of Opposition be sustained.
