that it will be damaged by the registration of the mark shown in the above-identified application, hereby opposes the same.

The grounds for opposition are as follows:

COUNT I

1. Young Carter LLC, a limited liability company of Florida, having an address at suite 1622, 1843 Page Leigh Cir # 1622, Apopka FL 32703 (“Applicant”), filed an application on April 28, 2016, seeking to register the trademark YOUNG CARTER EST. 2015, for the following products:


- Boxer briefs; Boxer shorts; Denim jackets; Denims; Hats; Long-sleeved shirts; Shorts; Shorts for Adults only; Sneakers; Sweaters for adults only; T-shirts for adults only; Tank-tops; Basketball sneakers; Clothing for athletic use, namely, padded shorts; Crew neck sweaters; Fight shorts for mixed martial arts or grappling; Fleece shorts; Panties, shorts and briefs; Short-sleeved or long-sleeved t-shirts; Underwear, namely, boy shorts; V-neck sweaters; Walking shorts in International Class 35;

2. The above-mentioned application is evidenced by the publication of said mark in the Official Gazette on October 11, 2016 under Ser. No.: 87/017,841. The application is based on intent to use.

3. For many years, Opposer has been engaged, by itself, its predecessors and affiliated companies, including but not limited to Giorgio Armani Corp., in advertising and sale, *inter alia*, of a variety products in U.S. interstate commerce using a stylized trademark consisting

of a stylized eagle (the “Eagle” Logo), as evidenced by registration of the same in the Principal Register with the U.S.P.T.O.

4. Opposer owns various U.S. registrations for the above-mentioned trademark, including but not limited to the following U.S. trademark registration:

5. Reg. No.: 3,362,601 was filed on September 29, 2005 and registered on January 1, 2008. It is now incontestable under Section 15 of the Trademark Act. Therefore, priority is not at issue and Opposer has superior rights in these trademarks.

6. The mentioned registration is valid and subsisting. A copy of the pertinent information from the USPTO database about such registration and application is attached as Exhibit A.

7. In addition to federal statutory rights inherent in the above-identified registration, Opposer has also obtained substantial trademark rights under common law in the above-listed trademarks, through the long and continuous trademark use in interstate commerce in connection with a variety of products, including but not limited to haute couture, ready-to-wear, leather goods, shoes, watches, jewelry, accessories, eyewear, cosmetics and home interiors.

8. For several years prior to Applicant’s filing date, Opposer advertised and sold a large number of products and services under the Eagle Logo.

9. Applicant is seeking registration for the mark YOUNG CARTER EST. 2015 and Design (sometimes referred to as “Applicant’s Mark”) *inter alia* in the same class as Opposer’s

mark Eagle Logo, and in connection with substantially similar and related products. Opposer's products in Class 25 are identified as clothing, namely, shirts, shorts, hats, skirts, pants, jackets; headgear, namely, caps, hats, beanies, visors; footwear in International Class 25, while Applicant's products are specified as boxer briefs; boxer shorts; denim jackets; denims; hats; long-sleeved shirts; shorts; shorts for adults only; sneakers; sweaters for adults only; t-shirts for adults only; tank-tops; basketball sneakers; clothing for athletic use, namely, padded shorts; crew neck sweaters; fight shorts for mixed martial arts or grappling; fleece shorts; panties, shorts and briefs; short-sleeved or long-sleeved t-shirts; underwear, namely, boy shorts; v-neck sweaters; walking shorts. Therefore, there is no doubt that Applicant's services are either identical or related to Opposer's products.

10. Additionally, Applicant's products fall within the natural scope of expansion of Opposer's services.

11. Persons encountering the parties' products under their respective marks are likely to assume that they originate at the same source, or that there is some association, sponsorship or endorsement between their sources.

12. In fact, Applicant's proposed mark and Opposer's trademark are highly similar appearance, and commercial impression. Applicant incorporates in its entirety an almost identical design as the Eagle Logo. Therefore, when applied to Applicant's services, the YOUNG CARTER EST. 2015 and Design trademark is likely to cause confusion, to cause mistake, and to deceive the trade and public, who is likely to believe that Armani is the source of Applicant's products or that such products are approved, endorsed, sponsored, produced under license, or somehow associated with Opposer. Therefore, the Board should find that there is

likelihood of confusion under Section 2(d) of the Trademark Act between Applicant's trademark and Opposer's Marks.

13. As a result, Armani would be injured by the registration of the applied-for YOUNG CARTER EST. 2015 and Design trademark.

14. Any defect, objection to, or fault found with Applicant's services provided under the YOUNG CARTER EST. 2015 and Design mark would necessarily reflect on and seriously injure the reputation that Opposer has established for its services and business.

COUNT II

15. Opposer repeats and realleges the allegations set forth in paragraphs 1 through 14 as though set forth herein.

16. Opposer's Eagle Logo was famous prior to the filing date of the opposed application.

17. Registration of the Applicants' Mark is likely to cause dilution of Opposer's Eagle Logo, to the injury of Opposer, by lessening the capacity of the Eagle Logo to identify and distinguish Opposer's goods, or otherwise diluting or tarnishing Opposer's famous Eagle Logo.

18. Based on the foregoing, the grant of a registration for Applicants' Mark as sought in the Application should be denied based on a likelihood of dilution of the distinctive quality of Opposer's famous Eagle Logo, in violation of Section 43(c) of the Lanham Act, 15 U.S.C. § 1125(c).

WHEREFORE, Armani prays that registration of the YOUNG CARTER EST. 2015 and Design mark in Application Serial No. 87/017,841 be refused and that this opposition be sustained.


