NOTICE OF OPPOSITION

Opposer, Hundred Acre Wine Estate, LLC (“Opposer”), a California limited liability company having a place of business at 1050 Adams Street, Suite C, St. Helena, California 94574, believes that it will be damaged by registration of the mark DRIL CIEN, shown in U.S. Application Serial No. 87/046,224 (“Application”), filed by Fernando D. Rojas (“Applicant”), and hereby opposes the same. Applicant claims the English translation of “dril” is a fabric such as linen, cotton or canvas, and the English translation of “cien” is one hundred.

As grounds for opposition, it is alleged that:

1. Opposer is in the business of producing and selling wine and is the producer of a well-known and critically acclaimed wine that is offered under the HUNDRED ACRE trademark. Opposer has been using HUNDRED ACRE as its trade name and the HUNDRED ACRE trademark since 2003, prior to the filing date of the Application. As a result, Opposer’s HUNDRED ACRE mark was well-known and recognizable to the public prior to the filing date of the Application for the proposed mark.

2. Opposer has long maintained registrations for the mark HUNDRED ACRE in Class 33 for wine in the United States Patent and Trademark Office (the “USPTO”). Among said registrations owned by Opposer (collectively “Opposer’s Marks”) are:

3. The registrations for Opposer’s Marks are valid and subsisting, and are owned by Opposer together with the business and goodwill connected therewith. Copies of the TSDR records for Opposer’s Marks showing the current status and title are attached hereto as **Exhibit A**.

Applicant’s Trademark Application

4. Applicant seeks registration of the mark DRIL CIEN (“Applicant’s Mark”) on the basis of an intent-to-use application filed on May 22, 2016, pursuant to Section 1(b) of the Lanham Act. Applicant claims the English translation of “dril” is a fabric such as linen, cotton or canvas, and the English translation of “cien” is one hundred.

5. As published on January 24, 2017, the Application covers “liquor” in International Class 33.

**CLAIM FOR RELIEF
Likelihood of Confusion
Section 2(d) of The Lanham Act; 15 U.S.C. §1052(d)**

6. Opposer hereby incorporates the foregoing paragraphs as fully set forth herein.

7. Section 2(d) of the Lanham Act, 15 U.S.C. §1052(d), prohibits registration on the principal register of a mark that consists of or comprises a mark which so resembles a mark previously used in the United States by another and not abandoned, as to be likely, when used on

or in connection with the goods of the applicant, to cause confusion, or to cause mistake, or to deceive.

8. Upon information and belief, the goods identified in the Application are related and/or complementary to the goods offered under Opposer's Marks.

9. Applicant's Mark so resembles Opposer's Marks, as to be likely, when used in connection with the goods identified in the Application, to cause confusion, to cause mistake, or to deceive.

10. The Trademark Trial and Appeal Board has authority under 15 U.S.C. § 1068 to refuse to register Applicant's Mark.

WHEREFORE, Opposer prays that the Application be rejected, that no registration be issued thereon to Applicant, and that this Opposition be sustained in favor of Opposer.

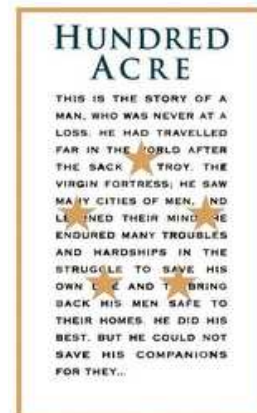
