NOTICE OF OPPOSITION

Opposer, The Behemoth, a California corporation, located and doing business at 302 Washington Street, # 616, San Diego, California 92103 (“Opposer”), believes that it will be damaged by the registration of U.S. Trademark Application Serial No. 87/085691 for the mark HOMINID GEAR in International Class 25 (the “Application”), filed by HominidGear, LLC, a Texas Limited Liability Company, with an address of 10603 Little Wind Cove, Austin, Texas 78730 (“Applicant”), and therefore opposes the same.

A Description of Applicant’s Application is as follows:

As grounds of opposition, Opposer alleges as follows:

1. Since at least as early as 2003, and long before Applicant filed the Application, Opposer has been using, and has registered its ALIEN HOMINID mark in connection with video games, apparel, including shirts, pants, jackets, sweatshirts, shorts, t-shirts, headwear, as well as key rings, figurines, and sporting goods. The use of Opposer's ALIEN HOMINID mark is valid and continuous.

2. Opposer is the owner of and relies upon incontestable United States Trademark Registration No. 2979780 for the mark ALIEN HOMINID for "Computer game programs; computer game discs; interactive video game programs; video game discs" in International Class 9. The application for this mark was filed on January 27, 2004, and registered on July 26, 2005. In connection with the goods listed in the registration, Opposer's ALIEN HOMINID mark was first used at least as early as July 18, 2003, and was first used in commerce at least as early as November 17, 2004. Opposer first used this mark and obtained its registration long before Applicant filed its Application.

3. Opposer is the owner of and relies upon United States Trademark Registration No. 4543682 for the mark ALIEN HOMINID for "Non-metal and non-leather key chains; non-

metal key rings; plastic key rings” in International Class 20, “Clothing, namely, shirts, pants, jackets, sweatshirts, shorts, t-shirts; headwear” in International Class 25, and “Skateboards and parts and accessories therefore, namely, skateboard decks; toys, namely, stuffed toys and action figures” in International Class 28. The application for this mark was filed on August 24, 2009, and registered on June 3, 2014. In connection with the goods listed in International Class 25 of the registration, Opposer’s ALIEN HOMINID mark was first used at least as early as July 22, 2003. In connection with the goods listed in International Class 28 of the registration, Opposer’s ALIEN HOMINID mark was first used at least as early as July 22, 2004. In connection with the goods listed in International Class 20 of the registration, Opposer’s ALIEN HOMINID mark was first used at least as early as March 22, 2013. Opposer first used this mark and obtained its registration long before Applicant filed its Application.

4. Opposer, through substantial use, advertising and promotion of its goods and services under Opposer’s ALIEN HOMINID mark, has acquired significant goodwill and consumer recognition, at great expense and effort, in Opposer’s ALIEN HOMINID mark.

5. Since at least as early as 2003, Opposer has invested substantial amounts of time, effort and money in Opposer’s ALIEN HOMINID mark throughout the United States. Opposer has used Opposer’s ALIEN HOMINID mark throughout the United States and such use has been continuous since at least as early as the dates of first use listed above. As such, in addition to the protection afforded Opposer by the federal registrations for Opposer’s ALIEN HOMINID mark, Opposer has extensive, non-registered statutory and common-law rights in Opposer’s ALIEN HOMINID mark for its goods and services throughout the United States. Furthermore, Opposer’s common law rights for Opposer’s ALIEN HOMINID mark predate the filing date of Applicant’s Application.

6. Opposer's registrations for Opposer's ALIEN HOMINID mark as specified in Paragraphs 2-3 above (collectively "Opposer's ALIEN HOMINID Registrations") are valid, subsisting, unrevoked, uncanceled, and not abandoned. As such, Opposer's ALIEN HOMINID Registrations constitute *prima facie* evidence of the validity of the registered Opposer's ALIEN HOMINID mark and of the registrations thereof, Opposer's ownership of Opposer's ALIEN HOMINID mark, and Opposer's exclusive right to use Opposer's ALIEN HOMINID mark in commerce in connection with the goods named therein, without condition or limitation. Opposer's Registrations also constitute notice to Applicant of Opposer's claim of ownership of Opposer's ALIEN HOMINID mark, all as provided in Sections 7(b), 22 and 33(a) of the Trademark Act of 1946, as amended. True and correct copies of printouts from the electronic database records (TSDR) of the U.S. Patent and Trademark Office showing the current status and title of Opposer's ALIEN HOMINID Registrations are attached hereto as Exhibit A.

7. Opposer also relies on its senior common law trademark rights in Opposer's ALIEN HOMINID mark as a ground for this Opposition.

8. Opposer's dates of first use and filing dates for Opposer's ALIEN HOMINID mark subject of Opposer's ALIEN HOMINID Registrations precede the Application's filing date.

Claim I – Applicant's Mark Creates a Likelihood of Confusion with Opposer's ALIEN HOMINID Mark

9. Opposer incorporates by reference Paragraphs 1-8 of the Notice of Opposition, as if fully set forth herein.

10. Applicant's HOMINID GEAR mark and Opposer's ALIEN HOMINID mark are highly similar in sight and sound, as well as commercial impression.

11. Applicant's Application is for "Clothing, namely, shirts; t-shirts; hats; visors; pants; shorts; head and neck wrap which provides uv protection; sun shirts; sweatshirts; hooded sweatshirts; outerwear, namely, parkas; jackets; coats; gloves; caps; socks" in International Class 25, which are identical or highly related to the goods listed in Opposer's ALIEN HOMINID Registrations.

12. Because the goods listed in Applicant's Application are identical or highly related to the goods listed in Opposer's ALIEN HOMINID Registrations, it is alleged that Applicant's consumers and trade channels are identical or overlapping with Opposer's consumers and trade channels.

13. In view of the above, it is alleged that Applicant's HOMINID GEAR mark so resembles Opposer's ALIEN HOMINID mark that Applicant's HOMINID GEAR mark will likely cause confusion or cause mistake or deceive under Section 2(d) of the Trademark Act, 15 U.S.C. § 1052(d). In view of Opposer's prior statutory and common law trademark rights, Applicant is not entitled to registration of the Application pursuant to Section 2(d) of the Trademark Act, 15 U.S.C. § 1052(d).

CONCLUSION

14. By reason of the foregoing, Opposer will be damaged by the registration of U.S. Trademark Application Serial No. 87/085691 for the mark HOMINID GEAR.

WHEREFORE, Opposer requests that U.S. Trademark Application Serial No. 87/085691 for the mark HOMINID GEAR be rejected and stricken, that no registration be issued thereon to Applicant, and this opposition be sustained in favor of Opposer.
