NOTICE OF OPPOSITION

This Notice of Opposition contests the application filed by Cassidy M. Ellis, (“Ellis”), filed on August 24, 2016, in Class 35 for “On-line retail store services featuring new and used luxury goods; On-line retail store services featuring new and used handbags; On-line retail store services featuring authenticated luxury goods; On-line retail store services featuring authenticated new and used handbags” under Section 1(b) of the Trademark Act, under Serial No. 87149184, seeking to register the service mark “THE REAL STYLE YOU” on the Principal Register, which application was published for opposition in the *Official Gazette* on January 4, 2017.

Opposer TVI, Inc., a Washington corporation (“TVI”), located and doing business at 11400 – SE 6th Street, Suite 220, Bellevue, Washington 98004, will be damaged by such registration, and hereby gives Notice of Opposition to the registration of said alleged mark.

On February 7, 2017 the Opposer filed and was granted a 90-Day Extension of Time to oppose until May 24, 2017.

The grounds for this Opposition are as follows:

1. TVI is a corporation organized under the laws of the State of Washington, having its principal office at 11400 – SE 6th Street, Suite, 220, Bellevue, Washington 98004.

2. For many years, and at least as early as October 1988, TVI, itself and through its affiliate companies (reference to TVI includes reference to its affiliate companies as appropriate), has continuously engaged in the business of providing retail department store services through its retail department store chains known as “Savers” and “Value Village.”

3. Since as early as March 16, 2006, TVI adopted and used the mark RESTYLE STORE continuously in interstate commerce in the United States and international commerce in North America as a service mark in connection with retail department store services for its retail department store chains.

4. TVI applied for, received, maintained, and continues to own United States Trademark Registration No. 3,293,933 for the mark RESTYLE STORE in International Class 35, a copy of which registration is submitted herewith as **Exhibit A**.

5. Since as early as March 16, 2006, TVI adopted and used the mark RECYCLE, REUSE, RESTYLE continuously in interstate commerce in the United States and international commerce in North America as a service mark in connection with retail department store services for its retail department store chains.

6. TVI applied for, received, maintained and continues to own United States Trademark Registration No. 4,264,176 for the mark RECYCLE, REUSE, RESTYLE in International Class 35, a copy of which registration is submitted herewith as **Exhibit B**.

7. Since as early as March 1, 2006, TVI adopted and used the mark RESTYLE continuously in interstate commerce in the United States and international commerce in North

America as a service mark in connection with retail department store services for its retail department store chains.

8. TVI applied for, received, maintained and continues to own United States Trademark Registration No. 4,334,352 for the mark RESTYLE in International Class 35, a copy of which registration is submitted herewith as **Exhibit C**.

9. Since its initial use of RESTYLE STORE; RECYCLE, REUSE, RESTYLE; and RESTYLE (“Marks”), TVI has sold millions of dollars worth of goods and services in the United States under and through its aforesaid Marks and has expended substantial amounts of money, time, and effort in advertising, promoting, and popularizing said Marks extensively in the United States and abroad. As a result of TVI’s use and advertising of its said Marks, the Marks are well known in the United States and elsewhere and recognized as identifying the high quality goods and services of TVI, including, without limitation, handbags, and luxury goods.

10. TVI’s use of its registered Marks precedes any use by Ellis of the proposed mark “THE REAL STYLE YOU,” which presumably has not been used per the filing of a section 1(b) intent-to-use application. Therefore, TVI has priority of use over Ellis’s use of the proposed mark.

11. Ellis’s use of its proposed mark in in Class 35 for “On-line retail store services featuring new and used luxury goods; On-line retail store services featuring new and used handbags; On-line retail store services featuring authenticated luxury goods; On-line retail store services featuring authenticated new and used handbags,” will be used to provide similar goods/services, in similar channels of trade, and around similar classes of purchasers as TVI’s Marks registered in Class 35 for “retail department store services.”

12. TVI's Marks and Ellis's proposed mark are so closely related that if the respective goods/services are provided under the same or confusingly similar marks, a likelihood of confusion will result under Section 2(d) of the Trademark Act, 15 U.S.C. § 1052(d).

13. Ellis's use of the term "THE REAL STYLE YOU" is confusingly and deceptively similar to TVI's Marks such that the trade and purchasing public will be confused and deceived by believing that Ellis's goods/services originate with or are otherwise authorized, sponsored, licensed, or associated with TVI under Section 2(d) of the Trademark Act, 15 U.S.C. § 1052(d).

14. Ellis's use of the term "THE REAL STYLE YOU" in Class 35 for "On-line retail store services featuring new and used luxury goods; On-line retail store services featuring new and used handbags; On-line retail store services featuring authenticated luxury goods; On-line retail store services featuring authenticated new and used handbags," will dilute the distinctive quality of TVI's Marks, which became famous among the general consuming public prior to Ellis's use of the "THE REAL STYLE YOU" mark, under Section 2(d) of the Trademark Act, 15 U.S.C. § 1052(d) and Section 43(c) of the Trademark Act, 15 U.S.C. § 1125(c).

15. By reason of all of the foregoing, TVI would be greatly damaged by the registration of "THE REAL STYLE YOU."

WHEREFORE, Opposer TVI prays that this Opposition be sustained and the application be denied and the mark refused registration.

TVI herewith submits this Notice of Opposition along with the requisite filing fee in the amount of \$400.00.
