**Motion for Suspension in View of Civil Proceeding**

The parties are engaged in a civil action which may have a bearing on this proceeding. Accordingly, Cave Man Kitchens Inc. (“Applicant”) hereby requests suspension of this proceeding pending a final determination of the civil action. Trademark Rule 2.117. In support of this Motion, Applicant submits herewith **Exhibit A**, which is a copy of a Complaint filed on February 22, 2018 by Applicant. The civil action is pending in United States District Court, Western District of Washington.

Whenever it comes to the attention of the Board that the parties to a case before it are involved in a civil action which may be dispositive of the Board case, the proceedings before the Board may be suspended upon final determination of the civil action. TBMP § 510.02(a). However, a civil action need not be dispositive on the issues for the Board to suspend proceedings. Ordinarily, the Board will suspend proceedings in the case before it if the final determination of the other proceedings may have a bearing on the issues before the Board. TBMP § 510.02, citing 37 C.F.R. § 2.117(a); see, e.g., New Orleans Louisiana Saints LLC v. Who Dat? Inc., 99 U.S.P.Q.2d 1550,1552 (TTAB 2011) (civil action need not be dispositive of Board proceeding, but only needs to have bearing on issues before the Board).

In the Complaint, Applicant alleges willful, deliberate infringement of its CAVEMAN KITCHEN and CAVEMAN marks by Caveman Foods, LLC. Additionally, in the Complaint,

Applicant seeks a determination by the District Court of priority, likelihood of confusion, and dilution.

Suspension of Board proceedings is within the discretion of the TTAB, and will generally be granted when a final decision of the court will likely be controlling on the issues to be decided by the TTAB. In *Whopper Burger, Inc. v. Burger King Corp.*, 171 U.S.P.Q. 805, 807 (TTAB1971), the Board suspended proceedings, finding that “There can be no doubt ... that the outcome of the civil action will have a direct bearing on the question of the rights of the parties herein and may in fact completely resolve all the issues.” There can be no doubt that issues involved in the civil action are involved here.

### **Conclusion**

In view of the fact that the pending civil action involves the determination of priority, likelihood of confusion, and dilution, and that issue will impact the pending trademark applications and the opposition to the same, the determination of these issues in the civil action will likely be dispositive of, or will at least have bearing on, this proceeding. Applicant therefore respectfully requests suspension of these proceedings pending determination of the civil action pursuant to Trademark Rule 2.117(a), 37 C.F.R. § 2.117(a).

Plaintiff Cave Man Kitchens Inc., (“Cave Man Kitchens”) complains of Defendant Caveman Foods, LLC., (“Caveman Foods”) as follows:

**NATURE OF LAWSUIT**

1. This is an action for infringement of federally registered trademark rights (Count I), false designation of origin under Section 43(a) of the Lanham Act (Count II), infringement of common law trademark rights (Count III), common law unfair competition (Count IV), cancellation of federally registered trademarks under Section 37 of the Lanham Act (Counts V, VI and VII) and for Declaratory Relief (Counts VIII and IX).

1 **THE PARTIES**

2 2. Cave Man Kitchens Inc., (“Cave Man Kitchens”) is a Washington Limited  
3 Liability Corporation headquartered in Kent, Washington and with a principal place of  
4 business located at 807 West Valley Highway, Kent, Washington 98032.

5 3. Cave Man Kitchens is engaged in the business of providing restaurant services,  
6 carry-out and delivery restaurant services, catering services and food preparation services in  
7 the United States and this District.

8 4. Upon information and belief, Defendant Caveman Foods, LLC., (“Caveman  
9 Foods”) is a California corporation with a principal place of business in Lafayette, California.  
10 Upon information and belief, Caveman Foods is engaged in the business of manufacturing,  
11 creating, selling and otherwise distributing in the United States and this District a variety of  
12 ready-to-eat food products including, but not limited to jerky, frozen, prepared and packaged  
13 meals consisting primarily of meat, fish, poultry or vegetables. Upon information and belief,  
14 Caveman Foods transacts business and has provided to customers in this judicial district and  
15 throughout the State of Washington. As set forth below, an actual justiciable controversy  
16 exists between the parties on such ready-to-eat food products.

17 **JURISDICTION AND VENUE**

18 5. This Court has exclusive jurisdiction over the subject matter of the Complaint  
19 under 28 U.S.C. § 1338(a). This Court has pendent jurisdiction, as well as jurisdiction under  
20 28 U.S.C. § 1338(b) over the common law claims for trademark infringement and unfair  
21 competition under the common law of the State of Washington. This Court has jurisdiction  
22 over the request for declaratory relief in Counts VIII and IX under 28 U.S.C. §§ 2201 and  
23 2202 in that an actual justiciable controversy exists between the parties as to the subject  
24 matter of those Counts.

25 6. Venue is proper under 28 U.S.C. § 1391. Defendant has purposefully availed  
26 itself of the privilege of transacting extensive business in the State of Washington.  
27

1 **BACKGROUND OF THE CONTROVERSY**

2 7. Since at least as early as December 21, 1971, Plaintiff Cave Man Kitchens Inc.  
3 has continuously used the terms CAVE MAN and CAVEMAN as trademarks for restaurant  
4 and catering services. Operating from substantially the same location in Kent, Washington  
5 over that time, Cave Man Kitchens has expanded its offerings from its original smoked  
6 chicken and meats to a wide variety of foods including, but not limited to, smoked and dried  
7 meats, sandwiches, salads, baked beans, coleslaw, soups, breads, sauces, and desserts. In  
8 addition to its original offerings, Cave Man Kitchens now offers carry-out and delivery  
9 dining services, catering services and food preparation services. The original Caveman  
10 Kitchen restaurant in Kent Washington is a Northwest institution that has attracted satisfied  
11 customers from throughout the country, including Presidents and celebrities as well as  
12 travelers, visitors and local residents. Cave Man Kitchens' smoked meats and other food  
13 products are now available not only at its original facility in Kent Washington but at other  
14 locations as well. As a result of its long presence, its reputation for fine, distinctive and  
15 quality products, and its long list of satisfied customers, Plaintiff's CAVE MAN name is well-  
16 known among people in this District as well as throughout the United States. The names and  
17 marks, CAVEMAN, CAVEMAN KITCHEN, and CAVE MAN KITCHENS have long been  
18 used to identify Plaintiff, Cave Man Kitchens and are associated in the minds of the  
19 consuming public with the distinctive, quality food products offered by Cave Man Kitchens.  
20 As a result of such substantially continuous, exclusive use of the CAVEMAN, CAVEMAN  
21 KITCHEN, and CAVE MAN KITCHENS marks in connection with its products and  
22 services, Cave Man Kitchens enjoys substantial, exclusive rights in those marks for such  
23 services. Cave Man Kitchens has achieved success and popularity in connection with its  
24 restaurant and catering services, which has resulted in significant media coverage and  
25 recognition.

26 8. To further establish and protect its rights in these marks, Cave Man Kitchens is  
27 the owner of United States Trademark Registration No. 3,222,887 for the mark CAVE MAN



1 KITCHENS for restaurant services, carry-out and delivery restaurant services, catering  
2 services, and food preparation services. Registration was granted on March 27, 2007 and is  
3 valid, subsisting, unrevoked, and uncanceled. A true and correct copy of Cave Man Kitchens'  
4 Registration and true and correct print-outs from the USPTO's electronic database showing  
5 the current status and title for Cave Man Kitchens' Registration is attached hereto as **Exhibit**  
6 **A.**

7 9. In addition to its foregoing United States Trademark Registration No.  
8 3,222,887, Cave Man Kitchens is also the owner of currently pending United States  
9 Trademark Registration Applications No. 86955705 and No. 86966805 filed with the United  
10 States Patent and Trademark Office on March 28, 2016 and April 6, 2016, respectively.  
11 Application No. 86955705 is directed to the mark, CAVEMAN KITCHEN, while Application  
12 No. 86966805 is directed to the mark, CAVEMAN. Each of these applications claims rights  
13 in International Trademark Class 043 for "Catering services; Food preparation services;  
14 Restaurant services; Restaurant services, namely, providing of food and beverages for  
15 consumption on and off the premises," and specifies a first use date of December 1, 1971.  
16 True and correct print-outs from the USPTO's electronic database showing the current status  
17 and title for Cave Man Kitchens' above-identified trademark registration applications are  
18 attached hereto as **Exhibit B.**

19 10. Cave Man Kitchens has achieved success and popularity in connection with its  
20 restaurant and catering services offered under its various CAVEMAN marks, which has  
21 resulted in significant media coverage and recognition. Through extensive sales, advertising,  
22 promotion, and unsolicited media coverage, among other things, Cave Man Kitchens' various  
23 CAVEMAN marks are famous and became famous long before 2005.

24 11. Long after Plaintiff Cave Man Kitchens' adoption and use of CAVEMAN and  
25 variants thereof for various food products and restaurant, catering and food preparation  
26 services, Defendant Caveman Foods, without the knowledge or authorization of Cave Man  
27 Kitchens, began using in commerce the mark CAVE MAN and variants thereof for food

1 products and food preparation services in competition with Cave Man Kitchens. In particular,  
2 Caveman Foods has applied for and received, from the United States Patent and Trademark  
3 Office, the following trademark registrations for the marks indicated:

4 Registration No. 4863604 CAVEMAN FOODS;

5 Registration No. 4841590 CAVEMAN JERKY;

6 Registration No. 4565451 CAVEMAN FOODS.

7 True and correct copies of these United States Trademark Registrations are attached as  
8 **Exhibit C.**

9 12. In addition to the United States Trademark Registrations listed in Paragraph 10  
10 above, Caveman Foods has applied for, and currently maintains United States Trademark  
11 Registration Applications for various forms of CAVEMAN trademarks as follows:

12 Application Serial No. 87166881 CAVE MAN;

13 Application Serial No. 87087186 CAVEMAN FOODS;

14 Application Serial No. 86169105 CAVE MAN & Design;

15 Application Serial No. 86169099 CAVE MAN & Design.

16 True and correct print-outs from the USPTO's electronic database showing the current status  
17 and title for Caveman Foods' above-identified trademark registration applications are  
18 attached hereto as **Exhibit D.**

19 13. On May 8, 2017, Plaintiff Cave Man Kitchens filed with the United States  
20 Patent and Trademark Office a Petition to Cancel the three United States Trademark  
21 Registrations identified in Paragraph 10. That Petition is currently Pending in the United  
22 States Patent and Trademark Office as Cancellation Proceeding No.92066099.

23 14. On April 20, 2017, Plaintiff Cave Man Kitchens filed with the United States  
24 Patent and Trademark Office Opposition No. 91234111 opposing the grant of the trademark  
25 registration application identified in Paragraph 11 above and opposing registration, by Cave  
26 Man Foods, of the various CAVEMAN marks identified in those pending trademark  
27 registration applications.

1           15.     On May 30, 2017 Defendant Cave Man Foods, in connection with Opposition  
2 No. 91234111 identified in Paragraph 13 above, filed a counterclaim seeking cancellation of  
3 Cave Man Kitchens' United States Trademark Registration No. 3,222,887.

4           16.     On June 28, 2017, Defendant Cave Man Foods, filed with the United States  
5 Patent and Trademark Office Opposition No. 91235296 opposing the grant of Plaintiff Cave  
6 Man Kitchens' Trademark Registration Applications No. 86955705 and No. 86966805  
7 identified in Paragraph 9 above and opposing registration, by Cave Man Kitchens, of the  
8 various CAVEMAN marks identified in those pending trademark registration applications.

9   **DEFENDANT'S UNLAWFUL ACTS**

10           17.     Upon information and belief, Defendant Cave Man Foods, with full awareness  
11 of Cave Man Kitchens' prior use of various forms of its CAVEMAN marks, adopted  
12 CAVEMAN as the central element of its own name and mark for use on goods and services  
13 substantially similar to those of Cave Man Kitchens and distributed through substantially the  
14 same channels of trade and to the same types of consumers as those of Cave Man Kitchens.  
15 Such use by Cave Man Foods of these various CAVEMAN marks in connection with the  
16 goods and services it offers is likely to cause confusion and/or mistake among consumers as  
17 to the origin of the goods and services provided by Cave Man Kitchens and Cave Man Foods.

18           18.     By seeking and obtaining United States Trademark Registrations of various  
19 forms of marks including the word CAVEMAN and the words, CAVE MAN for goods and  
20 services substantially similar to those of Cave Man Kitchens, and with full awareness of Cave  
21 Man Kitchens' prior use of CAVEMAN and CAVE MAN for such goods and services,  
22 Defendant Cave Man Foods unfairly encroaches on and infringes the prior rights of Plaintiff  
23 Cave Man Kitchens in its own CAVEMAN and CAVE MAN marks, and, accordingly,  
24 competes unfairly with Cave Man Kitchens.

25           19.     By filing and maintaining additional Trademark Registration Applications on  
26 various forms of marks including the word CAVEMAN and the words, CAVE MAN for  
27 goods and services substantially similar to those of Cave Man Kitchens, and with full

1 awareness of Cave Man Kitchens' prior use of CAVEMAN and CAVE MAN for such goods  
2 and services, Defendant Cave Man Foods unfairly encroaches on and infringes the prior rights  
3 of Plaintiff Cave Man Kitchens in its own CAVEMAN and CAVE MAN marks, and,  
4 accordingly, competes unfairly with Cave Man Kitchens.

5 20. By filing and maintaining its additional Trademark Registration Applications  
6 on various forms of marks including the word CAVEMAN and the words, CAVE MAN for  
7 goods and services substantially similar to those of Cave Man Kitchens, and with full  
8 awareness of Cave Man Kitchens' prior use of CAVEMAN and CAVE MAN for such goods  
9 and services, Defendant Cave Man Foods unfairly encroaches on and infringes the prior rights  
10 of Plaintiff Cave Man Kitchens in its own CAVEMAN and CAVE MAN marks, and,  
11 accordingly, competes unfairly with Cave Man Kitchens.

12 21. By filing and maintaining its counterclaim seeking cancellation of Cave Man  
13 Kitchens' United States Trademark Registration No. 3,222,887, Defendant Cave Man Foods  
14 unfairly encroaches on and infringes the prior rights of Plaintiff Cave Man Kitchens in its own  
15 CAVEMAN and CAVE MAN marks, and, accordingly, competes unfairly with Cave Man  
16 Kitchens.

17 22. By filing and maintaining its Opposition No. 91235296 opposing the grant of  
18 Plaintiff Cave Man Kitchens' Trademark Registration Applications No. 86955705 and No.  
19 86966805, Defendant Cave Man Foods unfairly encroaches on and infringes the prior rights  
20 of Plaintiff Cave Man Kitchens in its own CAVEMAN and CAVE MAN marks, and,  
21 accordingly, competes unfairly with Cave Man Kitchens.

22 23. Cave Man Kitchens does not consent to, sponsor, endorse, or approve of  
23 Defendant's use of marks containing the words CAVEMAN and/or CAVE MAN alone or in  
24 conjunction with a design, on any products or services.

25 24. Defendant's use of marks containing CAVEMAN and/or CAVE MAN in  
26 interstate commerce in connection with its products is likely to confuse, mislead, and deceive  
27 the public as to the origin of the marks, or potentially cause these persons to believe that the

1 products have been sponsored, approved, authorized, or licensed by Cave Man Kitchens,  
2 and/or that Defendant is in some way affiliated or connected with Cave Man Kitchens.

3 25. Because there is no affiliation between Cave Man Kitchens and Defendant,  
4 Cave Man Foods, Cave Man Kitchen has no control over the nature and quality of  
5 Defendant's products, or its brand message. Accordingly, not only are consumers likely to be  
6 confused or deceived regarding the source of Defendant's products, but the invaluable  
7 intrinsic brand equity and reputation of Cave Man Kitchens and the CAVEMAN and CAVE  
8 MAN marks will be directly diminished and diluted by association with Defendant's  
9 uncontrolled products, website, and unaffiliated branding efforts.

10 **COUNT I**

11 **FEDERAL TRADEMARK INFRINGEMENT**

12 **(Lanham Act § 32, 15 U.S.C. § 1114)**

13 26. Cave Man Kitchens hereby repeats and incorporates by reference Paragraphs  
14 1-25 above as if fully set forth herein.

15 27. Defendant Caveman Foods has infringed the registered CAVEMAN  
16 KITCHENS Mark through its manufacture, distribution and/or sale of it food products and  
17 services under various forms of the name CAVEMAN.

18 28. Defendant Caveman Foods' manufacture, distribution and/or sale of it food  
19 products and services under its various forms of the name CAVEMAN infringes Cave Man  
20 Kitchens' rights in its United States Trademark Registration No. 3,222,887 in contravention  
21 of Title 15 U.S.C. §1114.

22 29. Defendant Caveman Foods' use of the CAVEMAN name in interstate  
23 commerce in connection with its products and services is likely to confuse, mislead, or  
24 deceive the public as to the origin of the products and services, or cause these persons to  
25 believe that the products and services have been sponsored, approved, authorized, or licensed  
26

1 by Cave Man Kitchens and/or that Defendant Caveman Foods is in some way affiliated or  
2 connected with Cave Man Kitchens.

3 30. Caveman Foods' manufacture, distribution and/or sale of its food products and  
4 services under its various CAVEMAN names has caused and will cause Cave Man Kitchens  
5 great and irreparable harm unless enjoined by this court.

6 31. As a direct and proximate result of Defendant Caveman Foods' willful and  
7 deliberate conduct, Cave Man Kitchens has suffered, and will continue to suffer, substantial  
8 injuries, loss, and damage to its business and goodwill in an amount to be proved at trial.

9 32. If Defendant Caveman Foods is permitted to continue its willful and deliberate  
10 acts of infringement, Cave Man Kitchens will be irreparably harmed both within the United  
11 States and without. Monetary damages alone cannot compensate Cave Man Kitchens for the  
12 harm that Defendant will cause to it. Cave Man Kitchens is entitled to injunctive relief  
13 prohibiting Defendant Caveman Foods from using confusingly similar marks in connection  
14 with its products.

15 **COUNT II**

16 **FALSE DESIGNATION OF ORIGIN**

17 **(Lanham Act § 43(a), 15 U.S.C. § 1125(a))**

18  
19 33. Cave Man Kitchens repeats and realleges the allegations in Paragraphs 1  
20 through 32 as if fully set forth herein.

21 34. Defendant Caveman Foods' manufacture, distribution and/or sale of its food  
22 products and services under its various forms of the name CAVEMAN falsely designates the  
23 origin of Defendant Caveman Foods' food products and services in contravention of Title 15  
24 U.S.C. §1125(a).

25 35. Defendant Caveman Foods' manufacture, distribution and/or sale of its food  
26 products and services under its various forms of the name CAVEMAN is likely to cause  
27 confusion, or to cause mistake, or to deceive as to the affiliation, connection, or association of

1 Defendant Caveman Foods with Cave Man Kitchens, or as to the origin, sponsorship, or  
2 approval of its goods, services, and/or commercial activities

3 36. Defendant Caveman Foods' manufacture, distribution and/or sale of its food  
4 products and services under its various forms of the name CAVEMAN has caused and will  
5 cause Cave Man Kitchens great and irreparable harm unless enjoined by this court.

6 37. As a direct and proximate result of Defendant Caveman Foods' willful and  
7 deliberate conduct, Cave Man Kitchens has suffered, and will continue to suffer, substantial  
8 injuries, loss, and damage to its business and goodwill in an amount to be proved at trial.

9 38. If Defendant Caveman Foods is permitted to continue its willful and deliberate  
10 acts of infringement, Cave Man Kitchens will be irreparably harmed both within the United  
11 States and without. Monetary damages alone cannot compensate Cave Man Kitchens for the  
12 harm that Defendant will cause to it. Cave Man Kitchens is entitled to injunctive relief  
13 prohibiting Defendant Caveman Foods from using confusingly similar marks in connection  
14 with its products.

15 **COUNT III**

16 **STATE TRADEMARK INFRINGEMENT**

17 **(Common Law Trademark)**

18 39. Cave Man Kitchens repeats and realleges the allegations in Paragraphs 1  
19 through 38 as if fully set forth herein.

20 40. Defendant Caveman Foods' manufacture, distribution and/or sale of its food  
21 products and services under its various forms of the name CAVEMAN falsely designates the  
22 origin of Defendant Caveman Foods' food products and services in contravention of the  
23 common law of the State of Washington.

24 41. Defendant Caveman Foods' manufacture, distribution and/or sale of its food  
25 products and services under its various forms of the name CAVEMAN has caused and will  
26 cause Cave Man Kitchens great and irreparable harm unless enjoined by this court.  
27

**COUNT IV**

**STATE COMMON LAW UNFAIR COMPETITION**

4 42. Cave Man Kitchens repeats and realleges the allegations in Paragraphs 1  
5 through 41 as if fully set forth herein.

6 43. Caveman Foods' activities complained of herein constitute unfair and unlawful  
7 practices in violation of the common law of the State of Washington to the injury of Cave  
8 Man Kitchens and the public.

9 44. Defendant Caveman Foods' manufacture, distribution and/or sale of its food  
10 products and services under its various forms of the name CAVEMAN has caused and will  
11 cause Cave Man Kitchens great and irreparable harm unless enjoined by this court.

12 45. As a direct and proximate result of Defendant Caveman Foods' willful and  
13 deliberate conduct, Cave Man Kitchens has suffered, and will continue to suffer, substantial  
14 injuries, loss, and damage to its business and goodwill in an amount to be proved at trial.

15 46. If Defendant Caveman Foods is permitted to continue its willful and deliberate  
16 acts of infringement, Cave Man Kitchens will be irreparably harmed both within the United  
17 States and without. Monetary damages alone cannot compensate Cave Man Kitchens for the  
18 harm that Defendant will cause to it. Cave Man Kitchens is entitled to injunctive relief  
19 prohibiting Defendant Caveman Foods from using confusingly similar marks in connection  
20 with its products.

9 **DECLARATORY JUDGMENT OF RIGHT TO MAINTAIN UNITED STATES**  
10 **TRADEMARK REGISTRATION NO. 3,222,887**

11 80. Cave Man Kitchens repeats and realleges the allegations in Paragraphs 1  
12 through 79 as if fully set forth herein.

13 81. By virtue of the counterclaim for Cancellation of Plaintiff's Trademark  
14 Registration No. 3,222,887, Defendant Caveman Foods has filed with the United States Patent  
15 and Trademark Office in response to Cave Man Kitchen's Opposition No. 91234111, an  
16 actual case of controversy exists regarding Plaintiff Cave Man Kitchens' right to maintain and  
17 enforce that trademark registration .

18 82. Caveman Foods' counterclaim for Cancellation of Plaintiff's Trademark  
19 Registration No. 3,222,887 is without legal basis in that Cave Man Kitchen's use of its CAVE  
20 MAN KITCHENS mark long pre-dated any use by Caveman Foods of the words CAVE  
21 MAN or CAVEMAN. Furthermore, Cave Man Kitchens' Trademark Registration No.  
22 3,222,887 was duly and lawfully issued by the United States Patent and Trademark Office and  
23 has now become incontestable under 15 U.S.C. § 1065.

24 83. Because Cave Man Kitchens' Trademark Registration No. 3,222,887 was  
25 properly and lawfully obtained from, and issued by, the United States Patent and Trademark  
26 Office, and because that registration remains in force and is now incontestable, Caveman  
27 Foods' counterclaim for Cancellation of Plaintiff's Trademark Registration No. 3,222,887 is

1 without legal basis and cannot properly be maintained. This Court has jurisdiction to resolve  
2 this controversy under 15 U.S.C. § 1119.

3 **COUNT IX**

4 **DECLARATORY JUDGMENT OF RIGHT TO MAINTAIN UNITED STATES**  
5 **TRADEMARK REGISTRATION APPLICATIONS NO. 86955705 AND NO. 86966805**

6 84. Cave Man Kitchens repeats and realleges the allegations in Paragraphs 1  
7 through 83 as if fully set forth herein.

8 85. By virtue of Opposition No.91235296 filed by Defendant Caveman Foods with  
9 the United States Patent and Trademark Office opposing Cave Man Kitchens' pending United  
10 States Trademark Registration Applications Nos. 86955705 on CAVEMAN KITCHEN, and  
11 No. 86966805 on CAVEMAN, an actual case of controversy exists regarding Plaintiff Cave  
12 Man Kitchens' right to maintain these applications and obtain registration of these marks.

13 86. Caveman Foods' Opposition to Cave Man Kitchens' registration of these  
14 marks is without legal basis in that Cave Man Kitchen's use of its CAVE MAN KITCHENS  
15 and CAVEMAN marks long pre-dated any use by Caveman Foods of the words CAVE MAN  
16 or CAVEMAN.

17 87. Because Cave Man Kitchens' right to use CAVE MAN KITCHENS and  
18 CAVEMAN in connection with its goods and services 1 86955705 long predated any use by  
19 Caveman Foods of the same or similar marks, Caveman Foods' opposition to Cave Man  
20 Kitchens' registration of the mark identified in its pending Trademark Registration  
21 Applications Nos. 86955705 and No. 86966805 is without legal basis and cannot properly be  
22 maintained.

23 **PRAYER FOR RELIEF**

24 WHEREFORE, Cave Man Kitchens asks this Court to enter judgment against  
25 Defendant Caveman Foods and against its subsidiaries, affiliates, agents, servants, employees  
26 and all persons in active concert or participation with it granting the following relief:  
27



1 A. A judgment that that Defendant Caveman Foods has infringed United States  
2 Trademark Registration No. 3,222,887, pursuant to 15 U.S.C. § 1114;

3 B. A judgment that that Defendant Caveman Foods has infringed Cave Man  
4 Kitchens' common law rights in it various marks using the words, CAVE MAN and  
5 CAVEMAN;

6 C. A permanent injunction restraining and enjoining Defendant Caveman Foods,  
7 and all of its agents, successors and assigns, and all persons in active concert or participation  
8 with any of them from using the CAVEMAN or CAVE MAN, or any other mark or name,  
9 alone or in combination with other words or symbols, which is confusingly similar to the  
10 CAVEMAN or CAVE MAN, or which is likely to cause confusion or mistake, or to deceive,  
11 including any use on the Defendant's website or on the Internet;

12 D. A permanent injunction restraining and enjoining Defendant Caveman Foods,  
13 and all of its agents, successors and assigns, and all persons in active concert or participation  
14 with any of them from seeking registration of the CAVEMAN and/or CAVE MAN, alone or  
15 in combination with other words or symbols, which is confusingly similar to the CAVEMAN  
16 and CAVE MAN marks, or which is likely to cause confusion or mistake or to deceive;

17 E. An Order canceling Defendant Caveman Foods' Trademark Registrations Nos.  
18 4,863,604, 4,841,590, and 4,565,451;

19 F. An Order directing the Commissioner of Trademarks to refuse registration of  
20 the trademarks identified in Defendant Caveman Food's pending Trademark Registration  
21 Applications Nos. 87166881, 87087186, 86169105 and 86169099;

22 G. A declaration that Plaintiff Cave Man Kitchen's Trademark Registration No.  
23 3,222,887 was duly and lawfully issued by the United States Patent and Trademark Office and  
24 remains in full force and effect;

25 H. An Order directing the Commissioner of Trademarks to Dismiss Defendant  
26 Caveman Foods' Counterclaim seeking cancellation of Plaintiff Cave Man Kitchen's  
27 Trademark Registration No. 3,222,887;

1 I. A declaration that Plaintiff Cave Man Kitchen's has the right to register the  
2 trademarks identified in its pending United States Trademark Registration Applications Nos.  
3 86955705 and No. 86966805;

4 J. An Order directing the Commissioner of Trademarks to Dismiss Defendant  
5 Caveman Foods' Opposition No. 91235296 opposing Plaintiff Cave Man Kitchens' pending  
6 United States Trademark Registration Applications Nos. 86955705 and No. 86966805;

7 K. An order requiring Defendant Caveman Foods to deliver to Cave Man  
8 Kitchens all products, labels, marketing, promotional and other materials in its possession,  
9 custody, or control bearing the marks CAVEMAN and/or CAVE MAN, or any other mark or  
10 name, alone or in combination with other words or symbols, which is confusingly similar to  
11 the CAVEMAN and/or CAVE MAN marks, or which is likely to cause confusion or mistake  
12 or to deceive;

13 L. An accounting and an award to Cave Man Kitchens of all profits received by  
14 Defendant Caveman Foods to date of any kind made as a result of Caveman Foods'  
15 infringement, unfair competition, and dilution, such damages to be trebled pursuant to 15  
16 U.S.C. § 1117;

17 M. A finding that this case is exceptional and an award to Cave Man Kitchens of  
18 its attorneys' fees and costs as provided by 35 U.S.C. § 284;

19 N. Such other and further relief as this Court or a jury may deem proper and just.


