NOTICE OF OPPOSITION

Opposer 2323 N. Milwaukee LLC, an Illinois limited liability company with a principal place of business in Chicago, Illinois (“Opposer”), believes it will be damaged by registration of the mark shown in Application Serial No. 86837889 in the name of Applicants Douglas C. Yingling, Douglas B. Yingling, Darren Cregan and Heath Traver (“Applicants”), and hereby opposes the same.

As grounds in support of its opposition, Opposer alleges:

1. Opposer is engaged in the business of producing and selling craft beer through its related companies under the marks and trade names REVOLUTION and REVOLUTION BREWING and is owner of the trademarks REVOLUTION and REVOLUTION BREWING for beer.

2. Opposer's and its related companies' beer has won awards and considerable public recognition at such prestigious national and international beer competitions and festivals as the World Beer Cup, the Great American Beer Festival, and the Festival of Wood and Barrel Aged Beer, and Opposer has acquired substantial goodwill and value in the REVOLUTION and REVOLUTION BREWING marks and names.

3. In addition to its common law rights, Opposer is also the owner of U.S. Reg. No. 3,822,436 on the Principal Register of the U.S. Patent and Trademark Office for the REVOLUTION BREWING mark for beer. Opposer's registration for the REVOLUTION BREWING mark is valid, subsisting and incontestable, and a printout of the registration from the electronic database of the U.S. Patent and Trademark Office showing the current status and title of the registration is attached hereto as Exhibit A and submitted into evidence on behalf of Opposer in accordance with Rule 2.122 of the Trademark Rules of Practice.

4. Opposer and its related companies have used the REVOLUTION and REVOLUTION BREWING marks and trade names for many years prior to the filing date of the Application opposed and any date of first use upon which Applicants can rely.

5. On December 3, 2015, Applicants filed Application Serial No. 86837889 to register the mark REVOLUTIONARY BEER for "Beer" on an intent-to-use basis pursuant to Section 1(b) of the Trademark Act.

6. The word "BEER" in the proposed REVOLUTIONARY BEER mark is descriptive in connection with beer, and Applicants agreed to entry of a disclaimer of the descriptive word "BEER" by way of an Examiner's Amendment.

7. There is no issue as to Opposer's priority of use. Opposer has priority by virtue of both its ownership of incontestable Registration No. 3,822,436 for the mark REVOLUTION

BREWING and the use of the REVOLUTION and REVOLUTION BREWING marks and trade names for many years prior to the filing date of the Application opposed and any date of first use upon which Applicants can rely.

8. Applicants are in no way authorized, sponsored, or licensed by, or in any other way legitimately connected with, Opposer.

9. Applicants' proposed use and registration of the mark REVOLUTIONARY BEER is without Opposer's permission or authorization.

10. Opposer's REVOLUTION and REVOLUTION BREWING marks and trade names and Applicants' proposed REVOLUTIONARY BEER mark are similar in sight, sound, meaning and commercial impression.

11. The REVOLUTIONARY BEER mark, when used for the goods in the Application opposed, so resembles the REVOLUTION and REVOLUTION BREWING marks and trade names as to be likely to cause confusion, mistake, and/or deception within the meaning of Section 2(d) of the Trademark Act, to the consequent damage of Opposer.

12. Because Opposer possesses prior rights in the REVOLUTION and REVOLUTION BREWING marks and names, the registration sought by Applicants for the proposed REVOLUTIONARY BEER mark and the presumptions that would flow to Applicants from any such registration are inconsistent with Opposer's rights.

13. By reason of the foregoing, Opposer would be damaged by Applicants' registration of the mark REVOLUTIONARY BEER.

WHEREFORE, Opposer 2323 N. Milwaukee LLC respectfully requests that this opposition be sustained and the registration sought by Applicants in Application Serial No. 86837889 for the mark REVOLUTIONARY BEER be denied.
