Applicant Forbi, Inc., d/b/a Knowe (“Applicant”) hereby requests that the Trademark Trial and Appeal Board (“Board”) grant approval to amend its application, which is the subject of Opposition No. 91236190, under 37 C.F.R. § 2.133(a). Application wishes to remove the below stricken language in its application:

Telecommunication services, namely, transmission of voice, data, graphics, images, audio and video by means of telecommunications networks, wireless communication networks, and the Internet; providing video and audio teleconferencing; ~~video and audio broadcasting services via the Internet, namely, posting, displaying and electronically transmitting data, audio and video;~~ transmission of

sound, video and information from web cams, video cameras or mobile phones, all featuring live or recorded materials.

Thus, the amended mark description would read as follows:

Telecommunication services, namely, transmission of voice, data, graphics, images, audio and video by means of telecommunications networks, wireless communication networks, and the Internet; providing video and audio teleconferencing; transmission of sound, video and information from web cams, video cameras or mobile phones, all featuring live or recorded materials.

Opposer Minnesota Public Radio (“Opposer”) has consented to Applicant’s amendment set forth above. The request is made for the purpose of resolving pending Opposition 91236190. Applicant respectfully requests that the Board enter the requested amendment to the subject application.
