NOTICE OF OPPOSITION

Opposer SAND CPH A/S, ("Opposer"), a public limited liability company organized under the laws of Denmark, with an address of Agerskallet 2, Randers 8900, Denmark, believes that it will be damaged by registration on the Principal Register of the term "SANDRIVER & Design", as shown in U.S. Trademark Application Serial No. 87370054, for "clothing apparel, namely, scarves, mufflers, dresses, skirts, sweaters, coats, ponchos, jumpers, gloves, caps, blouses," in International Class 25, filed in the name of Xiuling Guo ("Applicant"), which published for opposition on July 18, 2017.

As grounds for this Notice of Opposition, Opposer alleges:

1. Opposer's filing of this Notice of Opposition is timely pursuant to 37 C.F.R. § 2.101. U.S. Trademark Application Serial No. 87370054 published for opposition on July 18, 2017. On August 17, 2017, Opposer filed a First 30 Day Request for Extension of Time to Oppose, which extended the deadline to September 16, 2017. On September 15, 2017, Opposed filed a 60 Day Request for an Extension of Time to Oppose for Good Cause, which extended the deadline to

oppose to November 15, 2017. Therefore, the present deadline to file a Notice of Opposition is November 15, 2017, and this Notice is being filed by the November 15, 2017 deadline.

2. Opposer is the owner of U.S. Trademark Registration No. 3046413 for "SAND" for "footwear and headwear; men's, women's clothing, namely, beachwear and coverups; clothing belts; blazers; blouses; coats; culottes; peddle-pushers; dresses; gowns; dressing and night gowns; gloves; jackets; jeans; jerseys; jumpers; jumpsuits; leggings; mittens; overalls; overcoats; pants; pantsuits; pullovers; robes; scarves; shawls; suits; skirts; shorts; slacks; sleepwear; trousers; smocks; tuxedos; stockings; suit coats; suspenders; sweat suits, pants, shorts and shirts; sweaters; vests; shirts; t-shirts; tank tops; ties; tights; topcoats; tops; underclothes; undergarments; underwear; camisoles; undershirts, chemise; underpants; slippers; socks; neckties; neckerchiefs; bandanas; mufflers," in Class 25; and "retail store services, featuring footwear and headwear; men's, women's clothing, namely, beachwear and cover-ups; clothing belts; blazers; blouses; capes; coats; culottes; peddle-pushers; dresses; gowns; dressing and night gowns; gloves; jackets; jeans; jerseys; jumpers; jumpsuits; leggings; mittens; overalls; overcoats; pants; pantsuits; pullovers; robes; scarves; shawls; suits; skirts; shorts; slacks; sleepwear; trousers; smocks; tuxedos; stockings; suit coats; suspenders; sweat suits, pants, shorts and shirts; sweaters; vests; shirts; t-shirts; tank tops; ties; tights; topcoats; tops; underclothes; undergarments; underwear; camisoles; undershirts, chemise; underpants; slippers; socks; neckties; neckerchiefs; bandanas; mufflers," in Class 35. This application was filed on July 16, 2004, registered January 17, 2006, and required Sec. 71 Declarations of Use were filed and accepted in 2012 and 2016.

(Registration Certificate and TSDR status report attached at Exhibit 1.)

3. Applicant filed U.S. Trademark Application Serial No. 87370054 for "SANDRIVER & Design" in the United States Patent and Trademark Office ("USPTO") on March 14, 2017 for use in connection with "clothing apparel, namely, scarves, mufflers, dresses, skirts, sweaters, coats, ponchos, jumpers, gloves, caps, blouses," in International Class 25.

4. U.S. Trademark Application Serial No. 87370054 was filed on March 14, 2017 on the basis of use of the mark in commerce under Section 1(a), with an asserted first use date of August 2015 and first use in commerce date of August 5, 2016.

5. Opposer has used the "SAND" mark in commerce in the U.S. in connection with clothing products in Class 25 and retail services for clothing in Class 35 since prior to Applicant's actual or constructive date of first use of the alleged mark "SANDRIVER & Design", continuously, until the present time.

6. Opposer has devoted substantial time, money, and effort in establishing and maintaining a high standard of quality for goods and services provided under its "SAND" mark. As a result, Opposer's "SAND" mark has become widely and favorably known to the public in connection with its clothing products and retail services for clothing, and Opposer has developed substantial goodwill and name recognition in its "SAND" mark.

7. Opposer currently uses its "SAND" mark in the U.S. in connection with a wide variety of clothing products and in connection with retail store services featuring clothing. Attached as Exhibit 2 are examples of Opposer's trademark and service mark use of "SAND".

8. There is no issue as to priority. The filing date of Opposer's U.S. Registration for "SAND" and Opposer's use of the "SAND" mark are earlier than Applicant's asserted first use date of its "SANDRIVER & Design" mark and earlier than the filing date of U.S. Application No. 87370054.

9. Applicant's proposed mark "SANDRIVER & Design" is confusingly similar to Opposer's registered trademark "SAND", due to the similarities in sight, sound, meaning and connotation, and the fact that Applicant's proposed mark wholly incorporates Opposer's registered mark "SAND".

10. The Class 25 goods covered in U.S. Application Serial No. 87370054 are highly related to, if not identical to, the Class 25 goods covered in U.S. Registration No. 3046413 and are highly similar to, if not identical to, the clothing goods sold in the retail store services covered in Class 35 in U.S. Registration No. 3046413.

11. As a result of the public's association of "SAND" with Opposer, as well as Opposer's prior rights in the "SAND" mark, Applicant's use and registration of the highly similar proposed mark "SANDRIVER & Design" for use in connection with Class 25 goods that are highly related, if not identical to, Opposer's Class 25 goods and Opposer's Class 35 retail store services featuring clothing, is likely to cause confusion, mistake or deception as to the source, origin or affiliation of Applicant's goods, in that consumers are likely to be confused that Applicant's "SANDRIVER & Design" products originate with, are affiliated with or are sponsored by Opposer.


12. If U.S. Trademark Application Serial No. 87370054 for the highly similar proposed mark "SANDRIVER & Design" is permitted to register despite this likelihood of confusion, Opposer's right to use its "SAND" mark will be impaired, and Opposer will be damaged.

WHEREFORE, Opposer prays that registration of the mark in U.S. Trademark Application Serial No. 87370054 be refused, and that this Opposition be sustained in favor of Opposer.
