**MOTION ON CONSENT
TO AMEND APPLICATION AND DISMISS PROCEEDINGS**

FMN, LLC (“Applicant”), by and through its undersigned attorneys, hereby submits the following Motion on Consent to Amend Application Serial No. 87157189.

Pursuant to TBMP § 514 and with the consent of Ringdale UK LTD. (“Opposer”), Applicant hereby requests that the identification of goods in Application Serial No. 87157189 be amended as indicated below. The grounds for the motion are as follows: The two parties involved in the present proceeding have reached an agreement which will allow the current dispute to be settled and the opposition proceedings to be dismissed. That agreement is conditional on an amendment to the identification of services in the application.

The current identification of services in the application is as follows:

Class 41: Providing an interactive website featuring technology that allows users to follow, interact with, and comment on their favorite personalities and celebrities.

The proposed amendment to the identification of services is as follows (amendments which consist of deletions are shown in bold and strikethrough below):

TBMP §514.01, 37 C.F.R. §2.133 permits the amendment of an application that is the subject of an active opposition proceeding with the consent of the other party and the approval of the Trademark Trial and Appeal Board (“TTAB”).

Applicant has obtained the consent of Opposer to file the present motion seeking to amend the application. The amended identification is within the scope of the current identification of services, and is, therefore, proper under Trademark Rule 2.71(a), C.F.R. § 3.71(a).


WHEREFORE, for the above reasons and pursuant to TBMP §514.01 and 37 C.F.R. § 2.133, Applicant hereby requests that the identification of services in Application Serial No. 87157189 be amended as requested above

Upon acceptance and entry of the foregoing amendment by the Board, Opposer and Applicant hereby consent to the dismissal of the subject Opposition.
