NOTICE OF OPPOSITION

Ninian Solutions Ltd., a company organized and existing under the laws of the United Kingdom, with its principal place of business located at 2nd Floor, Aldgate Tower, 2 Leman Street, London, UK E1 8FA, believes that it will be damaged by the registration of the mark TEAM HUDDLE, which is the subject of Application Serial No. 87/476,896, and hereby opposes same.

As grounds for this opposition, Opposer alleges that:

1. Ninian Solutions Ltd. (hereinafter "Opposer") is now offering, and has for several years offered, software for creating online workspaces in the United States under the trademark HUDDLE.

2. Opposer, for many years and since long prior to any date of first use upon which Applicant can rely, has adopted and used its HUDDLE mark to identify its software.

3. Opposer is the owner of U.S. Trademark Registration No. 4,018,398 for the mark HUDDLE for "Providing online nondownloadable software for creating online workspaces that enable project management, file-sharing, document sharing, task assignment and tracking, scheduling, and general collaboration," in International Class 42. This registration is valid, subsisting, unrevoked and uncanceled. A status printout associated with Opposer's registration upon which it will rely, as obtained from the USPTO TSDR database, is submitted herewith as Exhibit A.

4. Applicant, on June 6, 2017, filed an application to register TEAM HUDDLE for services described as "Software design and programming services for customer service applications, namely, customer service management, help desk, and customer support; providing temporary use of on-line non-downloadable customer service software for use in providing customer service management, help desk and customer support; Software as a service (SAAS) services featuring real-time non-downloadable software for collaborative use by customer-support agents for use in providing customer service management, help desk and customer support" in International Class 42.

5. The application was filed based on Applicant's bona fide intent to use of the mark in commerce.

6. The trademark in the opposed application as applied to the services set forth in that application is confusingly and deceptively similar to Opposer's previously used and registered HUDDLE mark.

7. Opposer believes and therefore alleges that the use and registration of the alleged trademark TEAM HUDDLE by Applicant will damage Opposer, for the reasons among others:

- a. That purchasers and persons in the trade will be deceived as to the source and origin of Applicant's services sold and offered under the TEAM HUDDLE mark; and
- b. Purchasers, persons in the trade and others will assume, contrary to fact, that Applicant's services are associated with, approved by, sponsored by or otherwise related to Opposer.

8. Registration of the mark sought by Applicant herein is barred by the provisions of Section 2(d) of the Trademark Act of 1946 for the reason that it consists of or comprises a mark which so resembles Opposer's previously used and registered trademark as to be likely, when applied to the services of Applicant, to cause confusion, mistake or deception.

WHEREFORE, Opposer respectfully requests that registration to Applicant be refused and that this Opposition be sustained.
