However, subject to the Board's approval of the above amendments and their entering into the file for US Serial No. 87420915, Opposer has indicated that it will withdraw the Opposition.

subsequent scheduling motion, if required, until the Board determines the present motion. Applicant trusts that, pursuant to TBMP § 514.02, the Board will not issue any notice of default while the present motion is pending.
