Applicant filed an application for its mark OB JEWELRY MASTERS ("Applicant's Mark") on July 17, 2017, under Serial No. 87530876 for "Jewelry; Jewelry and imitation jewelry" in International Class 014 and for "Retail jewelry stores" in International Class 035. Applicant's Mark was published for opposition on December 12, 2017.

Opposer filed an application for its mark JEWELRY MASTERS ("Opposer's Mark") on October 31, 2017, under Serial No. 87662677 for "Jewelry" in International Class 014.

On April 10, 2018, Opposer filed the present opposition with the United States Patent and Trademark Office ("USPTO").

1) Applicant Amend to application Serial No. 87530876.
