- 7. Opposer's mark CBN is a famous mark, as this Board has previously held. *The Christian Broadcasting Network, Inc. v. ABS-CBN International*, 84 U.S.P.Q. 2d 1560, 1567 (T.T.A.B. 2007).
- 8. Opposer has priority over Applicant with respect to the use and registration of the trademarks.

9. Applicant's Mark so resembles Opposer's Marks as to be likely to cause

confusion or to cause mistake or to deceive.

ADDITIONAL GROUNDS AS TO APPLICATION SERIAL NO. 79/197,514

10. As alleged above, Opposer's mark CBN is a famous mark, and is

distinctive inherently and/or through acquired distinctiveness.

11. Applicant's use of the mark BCBN in connection with the goods identified

in Application Serial No. 79/197,514 is likely to cause dilution by blurring or dilution by

tarnishment, thereby diluting the distinctive quality of Opposer's famous mark CBN.

WHEREFORE, Opposer prays that both Application Serial No. 79/197,514 and

Application Serial No. 79/975,367 be refused registration, and that this Opposition be

sustained in favor of Opposer.
