

**NOTICE OF OPPOSITION**

Opposer Wright & McGill Co. (“Opposer”), a Colorado corporation, having a place of business at 4245 East 46<sup>th</sup> Avenue, Denver, Colorado 80216, believes that it will be damaged by registration on the Principal Register of the mark “EAGLEZONE”, as shown in U.S. Trademark Application Serial No. 87/416,484, for “Bite indicators; Bite sensors; Decoys for hunting or fishing; Fish hooks; Fishing creels; Fishing tackle; Floats for fishing; Gut for fishing; Landing nets for anglers; Lines for fishing; Lures for hunting or fishing; Reels for fishing; Rods for fishing; Scent lures for hunting or fishing; Artificial fishing bait,” in Class 28, which published for opposition on March 6, 2018 (such mark, “Applicant’s Mark”).

As grounds for this Opposition, Opposer alleges:

1. Opposer’s filing of this Notice of Opposition is timely pursuant to 37 C.F.R. § 2.101, as U.S. Trademark Application Serial No. 87/416,484 (the “Application”) published for opposition on March 6, 2018. Therefore, the deadline to oppose the Application is April 5, 2018, and this Notice of Opposition is being filed prior to such April 5, 2018 deadline.






3. Opposer has used the “EAGLE CLAW” word mark and the eagle design mark in commerce in the U.S. since 1927 for such goods in International Class 28 including fishing tackle, bobbers, fishing creels, fish hooks, fishing reels, lures, fishing vests and fishing rod cases, and more.

4. Opposer is the owner of the only active U.S. Trademark Registrations for “EAGLE CLAW” in International Class 28.

5. Opposer is the owner of the only active U.S. Trademark Registrations for an eagle clutching a fish design mark in International Class 28.

6. Opposer has devoted substantial time, money, and effort in establishing and maintaining a high standard of quality for goods provided under its “EAGLE CLAW” and eagle design marks. As a result, Opposer’s “EAGLE CLAW” and eagle design marks have become widely and favorably known to the public in connection with its fishing products, and Opposer has developed substantial goodwill and name recognition in its “EAGLE CLAW” and eagle design marks.

7. Applicant filed the Application on April 19, 2017 for use in connection with “Bite indicators; Bite sensors; Decoys for hunting or fishing; Fish hooks; Fishing creels; Fishing tackle; Floats for fishing; Gut for fishing; Landing nets for anglers; Lines for fishing; Lures for hunting or fishing; Reels for fishing; Rods for fishing; Scent lures for hunting or fishing; Artificial fishing bait” in International Class 28.

8. The Application was filed on April 19, 2017 on the basis of use of the mark in commerce under Section 1(a), with an asserted first use date of April 19, 2017 and first use in commerce date of April 19, 2017.

9. There is no issue as to priority. The registration dates of Opposer’s U.S. Registrations in the “EAGLE CLAW” and eagle design marks are earlier than the filing, first use and first use in commerce dates by Applicant of Applicant’s Mark and the applicable first use and first use in commerce dates by Opposer of the “EAGLE CLAW” and eagle design marks are earlier than the first use and first use in commerce dates by Applicant of Applicant’s Mark.

10. Applicant's Mark is confusingly similar to Opposer's "EAGLE CLAW" and eagle design marks.

11. Applicant is currently using the "EAGLEZONE" mark for fishing products. *See* Exhibit 3 for Applicant's specimen of use filed with the USPTO; *see also* Exhibit 4 for a copy of the Application as filed and downloaded from the TSDR website records.

12. Applicant's goods identified in International Class 28 are identical or highly related to Opposer's goods identified in International Class 28.

13. Opposer's goods and Applicant's goods target similar consumers.

14. As a result of the public's association of "EAGLE CLAW" and the eagle design marks with Opposer, as well as Opposer's prior rights in the "EAGLE CLAW" and eagle design marks, Applicant's use and registration of the confusingly similar mark "EAGLEZONE" for use in connection with fishing goods is likely to cause confusion, mistake or deception as to the source, origin or affiliation of Applicant's fishing goods, because consumers are likely to be confused that Applicant's "EAGLEZONE" products are affiliated with or sponsored by Opposer.

15. Opposer's right to use its "EAGLE CLAW" and eagle design marks will be impaired, and Opposer will be damaged by the registration and use of Applicant's Mark by Applicant because Applicant's Mark is confusingly similar to Opposer's "EAGLE CLAW" and eagle design marks and confusion is likely to occur.

16. Opposer's "EAGLE CLAW" and eagle design marks were famous under 15 U.S.C. § 1125(c) for the goods identified in International Class 28 including, but not limited to, fishing tackle, bobbers, fishing creels, fish hooks, fishing reels, lures, fishing vests and fishing rod cases, and more, before the filing date of Applicant's Mark.

17. Opposer's "EAGLE CLAW" and eagle design marks became famous in connection with the goods identified in International Class 28 including, but not limited to, fishing tackle, bobbers, fishing creels, fish hooks, fishing reels, lures, fishing vests and fishing rod cases, and more, before the filing date of Applicant's Mark.

18. Opposer's "EAGLE CLAW" and eagle design marks became famous in connection with the goods identified in International Class 28 including, but not limited to, fishing tackle, bobbers, fishing creels, fish hooks, fishing reels, lures, fishing vests and fishing rod cases, and more, before the first use and first use in commerce dates of Applicant's Mark.

19. Opposer will be damaged by the registration and use of Applicant's Mark because Applicant's Mark will cause dilution by blurring of the distinctive quality of Opposer's famous "EAGLE CLAW" and eagle design marks under 15 U.S.C. § 1125(c).

WHEREFORE, Opposer prays that registration of the mark in U.S. Trademark Application Serial No. 87/416,484 be refused, and that this Opposition be sustained in favor of Opposer.
