STIPULATED MOTION TO EXTEND TRIAL CALENDAR FOR CAUSE

The parties to this Opposition hereby jointly and for good cause request a thirty day extension of the time for Applicant to file an Answer and the trial calendar in this case. On July 30, 2019, the Trademark Trial and Appeal Board granted Applicant's consented motion to further extend Applicant's time to file an Answer in the case, setting the new deadline for Applicant's Answer as August 28, 2019. The Board noted, however, that "Any future motion to extend or suspend which is based on settlement must be supported by a detailed report setting forth what progress the parties have made towards settlement."

Applicant and Opposer have, since inception, discussed this case via e-mail and telephone communications on a regular basis. The parties have exchanged numerous versions of a draft settlement agreement, and in an August 27 telephone call, the parties agreed that the case

appears to be near a resolution. There is a remaining issue that the parties view as confidential, but both parties are optimistic that the case will reach a resolution in the near future. In fact, both parties hope that no further extensions will be required and that the case will be settled prior to the next deadline. The parties are working towards this goal.

Based on the above, Applicant hereby requests and additional 30-day extension of the trial calendar in this case, including its date to file an Answer which is currently due August 28, 2019. The new Answer deadline would be September 27, 2019.

For the reasons set forth above, the parties file this Stipulated Motion to Extend Trial Calendar for Cause and request that the TTAB grant the parties' Motion.
