**JOINT MOTION TO EXTEND TIME TO ANSWER, DISCOVERY PERIOD AND
TRIAL DATES**

Opposer Reline America, Inc. (“Reline America”) and SML VERWALTUNGS GMBH (“SML”), by and through the undersigned counsel, hereby jointly move that the time for SML’s response and discovery and trial dates in this matter be extended by thirty (30) days to allow additional time for the parties to discuss resolution of this case.
