



RESPONSE TO ORDER TO SHOW CAUSE

1. Team 10 Inc. failed to file a response by September 5th because prior to and during the application process Team 10 was undergoing a restructure of their existing management staff and attorneys for the company. All prior existing staff were terminated and there was a complete overhaul of the management team. Due to this change in management all the critical paperwork in the office was being reviewed by the new management team and they missed this deadline. WHEREFORE Owner/applicant respectfully requests that we be granted 30 days in which to prepare and file a responsive pleading to this opposition.



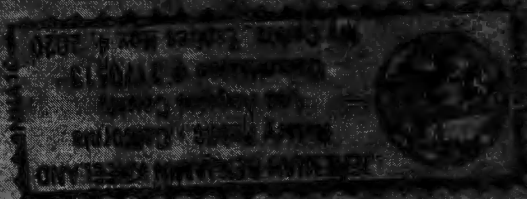
