NOTICE OF OPPOSITION

Opposer, Isaco International Corporation, a corporation duly organized and existing under the laws of the State of Florida, having an address at 5980 Miami Lakes Drive, Miami Lakes, Florida, 33014, believes that it may be damaged by registration of the mark GODPAPI shown in Application Serial No. 87/812,352 and accordingly hereby opposes issuance of same relative to the goods in International Class 025.

As grounds for this opposition, it is alleged that:

1. Since long prior to Applicant's February 27, 2018 filing date, Opposer or Opposer's predecessor-in-interest has been using the PAPI mark in association with clothing.
2. Opposer is the owner of United States Trademark Registration No. 2,161,178 for the mark "PAPI" for wearing apparel for men, namely, T-shirts, hats, undergarments, jogging suits, warm up pants, sweat shirts, sweat shorts, swimwear, bathing suits, beach and bathing coverups, tops, knit shirts, polo shirts, pullovers, vests, tank tops, athletic footwear, in International Class 25, which was registered on the Principal Register on June 2, 1998, based upon application Serial No. 74/702,454 filed in the United States Patent and Trademark Office on June 23, 1995, based on actual use at least as early as May 5, 1995. A copy of the Certificate

of Registration and a current printout of information from the electronic database records of the USPTO showing current status and title for United States Trademark Registration No. 2,161,178 are attached as Exhibit 1.

3. United States Trademark Registration No. 2,161,178 is in full force and effect and comprises conclusive evidence of the validity of the "PAPI" mark, of Opposer's ownership and of Opposer's exclusive right to use the "PAPI" mark in commerce and interstate commerce on or in connection with the goods specified in the Certificate of Registration, and as constructive notice of Opposer's claim of ownership under Title 15 U.S.C. §§ 1057, 1072, and 1115.

4. Opposer is the owner of United States Trademark Registration No. 3,660,872 for the mark "PAPI" for hosiery, socks, ties, underwear, boxers, briefs, neckties, loungewear, pajamas, nightwear, robes, sleep pants, sleep shorts, baseball caps, swimsuits, undershirts, shirts, zippered sweatshirts, in International Class 25, which was registered on the Principal Register on July 28, 2009, based upon application Serial No. 77/657,694 filed in the United States Patent and Trademark Office on January 27, 2009, based on actual use at least as early as May 5, 1995. A copy of the Certificate of Registration and a current printout of information from the electronic database records of the USPTO showing current status for United States Trademark Registration No. 3,660,872 are attached as Exhibit 2.

5. United States Trademark Registration No. 3,660,872 is in full force and effect and comprises conclusive evidence of the validity of the "PAPI" mark, of Opposer's ownership and of Opposer's exclusive right to use the "PAPI" mark in commerce and interstate commerce on or in connection with the goods specified in the Certificate of Registration, and as constructive notice of Opposer's claim of ownership under Title 15 U.S.C. §§ 1057, 1072, and 1115.

6. Opposer is the owner of United States Trademark Registration No. 4,292,533 for the mark "PAPI" for Footwear; shoes, sandals; active wear, namely, shirts and shorts;

formalwear, namely, socks; pants, shorts, sleepwear, hats, belts, and athletic wear, namely, T-shirts, shorts, warm-up pants, athletic support underwear and swimsuits, in International Class 25, which was registered on the Principal Register on February 19, 2013, based upon application Serial No. 77/331,178 filed in the United States Patent and Trademark Office on November 16, 2007, based on actual use at least as early as May 5, 1995. A copy of the Certificate of Registration and a current printout of information from the electronic database records of the USPTO showing current status for United States Trademark Registration No. 4,292,533 are attached as Exhibit 3.

7. United States Trademark Registration No. 4,292,533 is in full force and effect and comprises conclusive evidence of the validity of the "PAPI" mark, of Opposer's ownership and of Opposer's exclusive right to use the "PAPI" mark in commerce and interstate commerce on or in connection with the goods specified in the Certificate of Registration, and as constructive notice of Opposer's claim of ownership under Title 15 U.S.C. §§ 1057, 1072, and 1115.

COUNT I

Likelihood of Confusion

8. By reason of Opposer's and/or Opposer's predecessor-in-interest's use of the "PAPI" mark long prior to Applicant's filing of its application to register the "GODPAPI" mark, Opposer has rights superior to any rights of Applicant.

9. Opposer and/or Opposer's predecessor-in-interest has spent substantial sums in advertising and promotion and has sold substantial quantities of goods under its "PAPI" mark.

10. Opposer's "PAPI" mark has become impressed upon the minds of the trade and public as identifying Opposer's products, and as indicating the source of origin of products so marked as emanating from Opposer.

11. Opposer has built up a large and valuable business in its use of the "PAPI" mark, and its goodwill in this mark is of great value.

12. The word GODPAPI does not have any separate meaning or connotation.

13. The word GODPAPI can be broken into two components, "GOD" and "PAPI."

14. The second part of the GODPAPI mark is identical to and pronounced the same as Opposer's PAPI mark.

15. "God" is a known word that can mean a person or thing of supreme value.

16. The word GODPAPI incorporates Opposer's PAPI mark in its entirety and adds the word "God" to it.

17. People seeing the GODPAPI mark will thus assume that the goods sold thereunder are a variation or otherwise related to the PAPI mark

18. Opposer's "PAPI" mark and registration, and Applicant's "GODPAPI" mark are confusingly similar to each other in sound, pronunciation and commercial impression.

19. Opposer's goods, in connection with which Opposer uses its "PAPI" mark, and Applicant's goods in International Class 25, for which Applicant is attempting to register the "GODPAPI" mark in Application Serial No. 87/812,352, are the same or similar.

20. There are no limitations in the GODPAPI application for where the clothing will travel. Accordingly, both Opposer's goods and Applicant's goods as identified and recited in Application Serial No. 87/812,352, would travel in the same or similar channels of trade.

21. Accordingly, there is a likelihood of confusion between Opposer's "PAPI" mark and Applicant's "GODPAPI" mark.

22. Applicant's "GODPAPI" mark is deceptively similar to Opposer's "PAPI" mark so as to cause confusion and lead to deception as to the origin of Applicant's goods. If Applicant is permitted to register "GODPAPI" for its goods in International Class 25, as specified in

Application Serial No. 87/812,352, confusion in the public and trade resulting in damage and injury to Opposer is likely to be caused and would result by reason of the similarity between Applicant's "GODPAPI" and Opposer's "PAPI" marks, in that purchasers could be likely to buy Applicant's goods as specified in Application Serial No. 87/812,352 and mistake them for goods made, marketed or sponsored by Opposer. Any defect, objection or fault found with such goods of Applicant marketed under the "GODPAPI" mark could necessarily reflect upon and seriously injure the reputation and goodwill which Opposer has long prior established for its goods sold under Opposer's "PAPI" mark.

WHEREFORE, Opposer prays that application Serial No. 87/812,352 be rejected with respect to the goods in International Class 25, that no registration be issued to Applicant relative to the goods in International Class 25, and that this Opposition be sustained in favor of Opposer.
